A meeting of The Georgia State Board of Funeral Service was held on January 8, 2008 at 237 Coliseum Drive, Macon, Georgia. Draper Watson, Chairman, called the meeting to order at 10:07 a.m.

A quorum was established with members present being: Draper Watson, Chairman, David Roach, Terry Daviston, Thelon Hamby, Lauren McDonald, Linda Ware, and Nancy Kennedy.

Approval of Minutes:

Mr. Hamby moved, Ms. Ware seconded, and the Board approved the minutes of the December 11, 2007 meeting.

Ms. Ware moved, Ms. Kennedy seconded, and the Board voted to accept the Order Accepting Fine Monies for the following:

FEST000541: Thornton's Funeral Home, Hazlehurst: Inspection citation of \$100 for failure to maintain the required minimum inventory of eight adult caskets. The inventory was deficient by one casket.

FEST001352: Ponders Funeral Home Inc. & Cremation, Dalton: Inspection citation of \$800 for failure to maintain the required minimum inventory of eight adult caskets. No caskets were in the inventory.

FEST001070: Alvie Coes Funeral Home, Unadilla: Inspection citation totaling \$100 for two incidents of failure to maintain in inventory the required 24 bottles of arterial fluid and 24 bottles of cavity fluid in the embalming room.

FEST001525: Peoples Funeral Home, Abbeville: Inspection citation of \$100 issued which included \$50.00 for failure to maintain in inventory the required 24 bottles of arterial fluid and 24 bottles of cavity fluid in the embalming room, and \$50 for failure to display current licenses for the establishment, embalmer, funeral director, or any apprentices licensed with the establishment.

FEST000367: Walker Funeral Home, Carrollton: Inspection citation of \$200 issued for failure to keep all tables and instruments in the embalming room in a sanitary and clean condition.

FEST001630: Nance & Sons Mortuary, Inc., Cordele: Inspection citation of \$350 which includes a \$50 fine for failure to display current licenses for the establishment, embalmer, funeral director, or any apprentices licensed with the establishment; and a \$300 fine for failure to maintain the required minimum inventory of eight adult caskets. Mr. Hamby moved, Ms. Ware seconded, and the Board voted to refer the request of SB to the Attorney General's Office.

Mr. Hamby moved, Ms. Ware seconded, and the Board approved the request for a 2nd 90-day grace period for Maurice Myles & Sons Funeral Home (FEST001542) of Rome, GA.

Ms. Ware moved, Ms. Kennedy seconded, and the Board made the decision to table discussion of a letter from the Cremation Society of the South until the next meeting.

Mr. Hamby moved, Mr. Daviston seconded, and the Board made the request for assistance from the Attorney General's office for collection of unpaid fines inspection citations of funeral establishments.

FEST001487: Ms. Kennedy moved, Ms. Ware seconded, and the Board denied the request submitted by Angel Heights Funeral Service of Hawkinsville, GA in reference to the inspection citation.

FEST000673: Ms. Ware moved, Mr. McDonald seconded, and the Board denied the request submitted by Pasley-Fletcher Funeral Home, Inc. of Thomaston, GA in reference to the inspection citation. Mr. Roach recused himself from the vote.

Mr. Roach reported on the meetings of the study committees sponsored by Representative Chuck Simms. Three meetings were held in various locations around the state. The meetings were open to the public for input on funeral and cemetery issues. Several issues were discussed, and possible legislation will be presented during the 2008 session of the General Assembly.

Mr. Hamby moved, Mr. Roach seconded, and the Board voted to establish a policy that pending applications are valid for 12 months, after which, all incomplete applications will be administratively withdrawn, and a new application and fees will be required to continue pursuit of licensure.
