**Rick Thompson established** that a quorum was present and the Georgia Athletic and Entertainment Commission meeting that were scheduled to begin at 11:00am and was called to order at 11:02am.

**Motion to Approve** the commission meeting minutes from February 20<sup>th</sup>, 2014. Commissioner J.J. Biello makes a motion to approve. Commissioner Don Geary seconds and the Commission votes 5-0 to approve.

**Motion to Approve** the 4/19/2014 Undisputed Productions event permit. Vice Chairman Hunter Towns makes a motion to approve. Commissioner Geary seconds and the Commission votes 5-0 to approve.

**Motion to Approve** the 4/20/2014 Undisputed Productions event permit. Commissioner Geary makes a motion to approve. Commissioner Moses Ector seconds, and the Commission votes 5-0 to approve.

**Motion to Approve** the 4/26/2014 Conflict MMA Promotions event permit. Commissioner Ector makes a motion to approve. Vice Chairman Towns seconds, and the Commission votes 5-0 to approve.

**Motion to Approve** Martez Barnes being able to boxing, since he is over the age of 38. Vice Chairman Towns makes a motion to approve. Commissioner Geary seconds and the Commission votes 5-0 to approve.

**Discussion** of possible rule change to 85-2-.05(5). Commissioner Geary makes a motion to adopt the proposed rule and send it to the Attorney Generals office to get the

**Discussion** of possible rule change to 85-3-.10. Commissioner Geary makes a motion to adopt the proposed rule. Commissioner Ector seconds and the Commission votes 5-0 to approve.

**Discussion** of possible rule to 85-3-.23. Commissioner Geary makes a motion to adopt the proposed rule. Vice Chairman Towns seconds and the Commission votes 5-0 to approve.

**Motion to Amend** the Agenda by Commissioner Geary. Vice Chairman Towns seconds and the Commission votes 5-0 to amend.

**Commissioner Geary** makes a motion to adopt the World Anti-Doping Agency (WADA) policy on Testosterone Replacement Therapy (TRT) effective immediately until rules can the rule is looked at further. Commissioner Biello second and the Commission votes 5-0 to approve. Reagan Dean said this would have to be a policy until a formal rule is in place.

**Commissioner Geary** makes a motion to have this placed on the April Commission meeting for further discussion. Commissioner Ector seconds and the Commission votes 5-0.

**Attorney General's Report:** None

**Executive Director's Report:** Mr. Woodruff stated that the March 1<sup>st</sup> boxing shows had some fighters with behavioral issues towards the Commission. Commissioner Geary makes a motion to send a letter to appear to the fighters from March 1<sup>st</sup> show. Commissioner Ector seconds and the Commission votes 5-0 to notify the fighters.

Executive Woodruff stated there were similar issues from the February 23<sup>rd</sup> show with fighters and at the weigh in. Vice Chairman Towns makes a motion to send them letters to appear in front of the Commission. Commissioner Geary seconds and the Commission votes 5-0 to notify the people.

**Public Comment:** There was no public comment.

**David Oblas:** Status of the smoker events. Mr. Woodruff said nothing was ever submitted over and it was his mistake.

**Motion to adjourn.** Commissioner Ector makes a motion to adjourn. Commissioner Geary seconds and the Commission voted 5-0 to adjourn.
