**Rule Wavier for Andy Nguyen.** Vice Chairman Hunter Towns makes a motion to approve the wavier to allow Andy Nguyen to compete in an amateur Muay Thai event without headgear. Commissioner Ector seconds and the Commission votes 5-0 to approve.

**Discussion on GAEC Policy about treatment of staff.** Commissioner Biello makes a motion to turn the policy into a rule and to post the rule for 30 days for public comment. Commissioner Geary seconds and the Commission votes 5-0 to post the rule.

**Discussion on Jesus Tavera's behavior from February 23, 2014.** Commissioner Geary makes a motion to move to July for a final decision, and offers an invitation to Mr. Tavera to attend the meeting. Commissioner Biello seconds and the Commission votes 5-0 to move to July.

**Discussion with Jaral Bowman about San Shou.** Commission Geary makes a motion to table this until July, when more Commissioners are present and there is more research about this style of martial arts. Commissioner Biello seconds and the Commission votes 5-0 to table.

**Attorney General's Report:** Reagan Dean has a report on the Route 30 Promotions final verdict, he would like to have the Commission vote to approve and sign the decision at the July meeting.

**Executive Director's Report:** Matt Woodruff said that even though Shannon Briggs was suspended in the state of Georgia, he was scheduled to fight in Oklahoma, and that he would contact that Commission about Mr. Briggs behavior.

**Public Comment:**

**Barry Smith** wanted to ask the Commission if they would approve an event permit for July 17<sup>th</sup>. Mr. Smith did not meet the deadline for his event to be on the agenda and No Motion was made to approve the event permit.

**Stephen Upchurch** wanted to ask the Commission if they would please start to provide the fighter scales for weigh ins. Commissioner Geary said that this matter will be formally placed on the July meeting.

**Motion to adjourn.** Chairman Thompson makes a motion to adjourn. Commissioner Geary seconds and the Commission voted 5-0 to adjourn.
