(iii) Additional verification of any requirements or credentials, as the Board may deem necessary.

(2) An applicant for reinstatement who is unable to verify active practice of practical nursing as a licensed practical nurse within the five (5) year period preceding the date of application shall be required to pursue further training which may include, but is not limited to the following:

(a) Successful completion of a board approved practical nursing program followed by taking the licensing examination.

(b) A refresher program as described in 400-2-.04 (2)(b).

(c) The licensing examination in use at the time of application.
