President Dumas established that a quorum was present and called the Board meeting to order at 9:06 a.m.

Agenda: Ms. Mitchell moved, Ms. Hilliard seconded, and the Board approved the Agenda as written.

Minutes: Ms. Hilliard moved and Ms. Bellville seconded and the Board approved the minutes from the May, 2005 Board meeting as written.

Report from the Secretary of State

Ms. Meadows explained that she had been meeting with each Board, bringing greetings from the Secretary of State and to tell how much she appreciates all of the work that the Licensed Practical Nursing Board had been doing. Basically, she explained that every licensee pays a fee biennially and that these fees are then placed in the general fund. Then, the boards have to ask for the money back through the budget process. Of the \$15,000,000 transmitted to the general funds, only \$5,000,000 was returned to the boards and the balance of the money was used to support other governmental agencies. We are now in a new fiscal year, and hopefully, we will be seeing some improvement. We are currently working on the 2006 budget and we are going to try to change the imbalance between the fees taken in and the amount of money that comes back to the Boards. The bottom line is that we have \$600,000 in the budget for the new Residential Contractor Board and we would like for the Board to continue their efforts to get all of the fees generated returned to the Boards through visitations with their Legislators and asking that these funds be returned to the Boards.

We are currently doing 133% more than we did ten years ago with 8% less staff. How can we work more efficiently with the staff we have? On-Line Renewals have helped to take up the slack with 127,000 of 144,000 licensees renewing on line. Of the 28,000 LPN renewals, 78% or 21,500 renewed on line.

Ms. Mitchell expressed her concerns over the salary and education requirements for the Education Consultant position, which has now been vacant one year. The Board does not have anyone looking at the nursing programs with quite a few required site visits missed this past

year. She would like to see the salary requirement higher to attract more applicants. Ms. Meadows stated that they would examine the salary levels again for that position and possibly re-evaluate qualifications and minimum starting salary.

Ms. Bellville moved and Ms. Mitchell seconded and the Board voted to enter into Executive Session in accordance with O.C.G.A. §43-1-2(k)(1), (2) and (4); §43-1-19(h)(2), (3) and (4) and O.C.G.A. §43-1-19(h); 50-14-2(1) to deliberate on investigations and applications and receive information on application and investigative reports and the attorney general's report. Voting in favor of the motion were Ms. Mitchell, Ms. Hilliard, Ms. Dumas and Ms. Bellville. The Board concluded executive session in order to vote on these matters and to continue with the public session.
