Ms. Owensby welcomed the representatives from Bainbridge College campus to the meeting to discuss their main campuses low pass rates and, to request Board approval to begin the process for development of a satellite campus in Early County, an Albany Technical College prior satellite site currently under withdrawn status for non-compliance.

Due to passing rates falling below 80% two consecutive years, Bainbridge College has been placed on Conditional status consistent with Board rule 400-3-.02. Program Director D. Carmichael presented to the Board the programs intentions to correct their non-compliant pass rate:

- The hiring of three additional faculty
- Curriculum changes to better equip students for the NCLEX exam
- Will no longer utilize the Albany facility as a clinical site; will utilize the Dolton Facility instead
- Faculty will encourage the August graduating class to schedule and take the NCLEX exam as soon after graduation as possible
- Strong community support with regard to Board consideration of re-opening of the Albany Technical College's Early County satellite site
- 2006 calendar year to date, the main campus has a passing rate of over 92% (verified by ED through NCSBN reports).

Following discussions with the Bainbridge representatives, Ms. Mitchell moved and Ms. Shaw seconded and the Board voted to allow Bainbridge College to proceed with the preliminary paperwork for the development of a satellite site, however, with the understanding that the Board reserves the right to delay final approval until the main campus program is in compliance with Board rules and regulations.

The Board adjourned at 11:00 a.m.

98 students and faculty representatives from 14 Board approved Georgia practical nursing programs.

Ms. Owensby greeted the attendees, explained her role as the Vice President of the Georgia Board of Examiners of Licensed Practical Nurses and introduced the Board Members and Assistant Attorney General. She stated she has worked for Madison Health and Rehabilitation for many years.

Ms. Hilliard discussed her role as a Board Member and the fact she has worked in Long Term Care facility. The best advice she wanted to offer the group was "if you think it just don't do it. "

Ms. Shaw discussed her role as the Educator on the Board. She is the Director of Instruction at Middle Georgia Technical College and has been a Nurse Educator for many years. She stated to the attendees that members appointed to the Board are appointed to protect the public. She asked the attendees if there were any faculty present and if so, to please stand up and introduce yourself and your school. The Board periodically evaluates nursing education programs, and, provides consultation on nursing education in addition to monitoring the pass/fail rates on the NCLEX of first time takers. She stated that this week the Board had approved over 200 applicants for licensure.

Ms. Taylor discussed her role as a Board Member. She stated she retired from nursing in 2004 but remains active both on the Board and the Georgia Association for Licensed Practical Nurses. She told the students to stay focused on your patient, know laws and rules, and that Attitude will determine your Altitude.

Ms. Mitchell stated she has been a Registered Nurse for 25 years. She has served on the Board for about 5 years and her functions are to receive and review all complaints and make appropriate recommendations on each one. She stated to the attendees that a new certification or professional licensure has passed legislation titled "Qualified Medication Aide". The only facilities that these QMA'S initially will work in are Community Living Arrangements. The initial Pilot Project will take place only at Atlanta Technical College.

Ms. Jackson stated her role as the Assistant Attorney General handling disciplinary matters as well as Laws and Rules for the Board. She stated she also is the Assistant Attorney General for several other Boards for the State. She stated that Nurses keep us alive and we understand the

daily challenges that may occur on a daily basis. She stressed that each student become familiar with the Laws and Rules governing the Board as well as the scope of practice. She spoke about the Senate 480 Bill summarization of changes that have occurred. If anyone chooses to do drugs, then they will not have a licensed in this state.

Ms. O' Bryant encourages everyone to join the Georgia Licensed Practical Nurses Association. "It is your association and you will have the opportunity to meet with other Georgia Licensed Practical Nurses.

The Board answered questions on the following topics:

- Will Qualified Medication Aides affect the jobs of the LPN'S?
- Who will supervise the Qualified Medication Aides?
- What type of education is needed to become a Qualified Medication Aide?
- Where can students find the scope of practice?
- What is Qualified Medication Aides involvement in other schools?

Following a period of brief questions and answers, and there being no further new or old business for the Board to discuss, Ms. Taylor moved and Ms. Mitchell seconded and the meeting was adjourned at 2:00pm.
