Izlar called the meeting to order at 8:00 a.m. on Wednesday, August 15, 2018. A quorum to conduct disciplinary matters was determined to exist.

**EXECUTIVE SESSION**

Rowe moved, Blalock seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§43-1-2(k); 43-1-19(h); 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative cases and pending cases. The motion passed unanimously.

**RNI180161** – Bryant moved to refer to the Attorney General's Office for a summary suspension. May petition to lift with documentation of six (6) to eight (8) weeks intensive outpatient program and a safe to practice statement from an addictionologist. Fletcher seconded the motion and it carried unanimously.

**RNI181361** – Rowe moved to refer to the Attorney General's Office for a summary suspension. May petition to lift with documentation of successful completion of treatment and at least one (1) quarter of full compliance of consent order and a safe to practice statement from an addictionologist. Hooper seconded the motion and it carried unanimously.

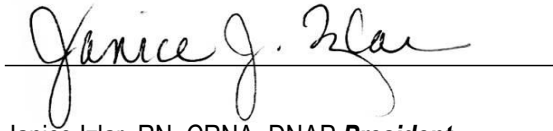

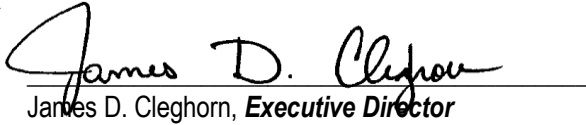
**RNI181433** – Bryant moved to rescind the previous Board motion and issue order lifting suspension. Train seconded the motion and it carried unanimously.

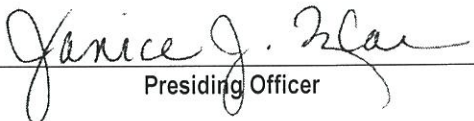
**AFFIDAVIT SUPPORTING CLOSING OF

The Georgia Open Meetings Act, O.C.G.A. § 50-14-1 *et seq.*, requires that all meetings of an entity covered by the statute must be open to the public unless there is some specific statutory exception which permits the closing of the meeting. 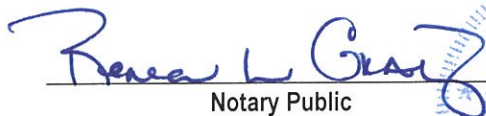
**Comes now the presiding officer identified below and, before an official duly authorized to administer oaths, makes this affidavit in satisfaction of the statutory requirements outlined above.**
