- Request temporary Georgia MFT license to provide online services to a client residing in Georgia. Currently is a registered MFT Intern in the State of Florida. Response: There is no “temporary license” provision; she must apply for licensure in Georgia.
- Karrie Gurwood, MSW
 - Request to obtain supervision hours via Skype from South Carolina. Response: Request Ms. Gurwood to file a Petition for Variance or Waiver of a Board rule and to clarify her request and circumstances to substantiate a hardship strict application of all or part of a Board rule will affect her.

Petition for Variance/Waiver Requests:

- Virginia Cailleteau – Rule 135-5-.04 Licensure Requirements

Mr. Bacon motioned, Mr. Perryman seconded, and the Board voted to deny the variance/waiver request. The Board cannot vary the law. The law, Section 43-10A-3(16), states that a supervisor is either licensed under this chapter (a Georgia Licensee) or is a psychiatrist or a psychologist. None opposed, motion carried.

- Connie Plunkett-Thompson, LPC004548 - Rule 135-9-.02 CE Documentation

Mr. Bacon motioned, Mr. Perryman seconded, and the Board voted to deny the variance/waiver request due to inadequate documentation. None opposed, motion carried.

- Nena Rybarczyk - Rule 135-5-.04 Licensure by Endorsement

Mr. Livingston motioned, Ms. Barker seconded, and the Board voted to deny the variance/waiver request due to insufficient evidence of hardship. None opposed, motion carried.

- Courtney Sims-Johnson – Rule 135-5-.02(A)B Professional Counselors

Ms. Barker motioned, Mr. Perryman seconded, and the Board voted to deny the variance/waiver request due to insufficient evidence of hardship. None opposed, motion carried.

- Christy Morrow - Rule 135-9-.01 CE Requirements

Mr. Livingston motioned, Ms. Barker seconded, and the Board voted to deny the variance/waiver request due insufficient evidence of hardship. None opposed, motion carried.

- Constance Teel-Brown - Rule 135-5-.04 Licensure by Endorsement

Mr. Bacon motioned, Mr. Livingston seconded, and the Board voted to deny the petition as it is unnecessary and should be withdrawn. None opposed, motion carried.

Associations – Board Update

- Catherine Ivy, National Association of Social Workers (NASW)
 - Issue of lapsed licenses due to failure to provide secure and verifiable document (SVD)?
Response: Licenses for Social Workers expired in September 30, 2012. The online renewal form noted the new Secure and Verifiable Document (SVD) requirement on 4 of the 5 webpages, in addition to e-mails sent to licensees and information is posted on the websites. The Paper renewal form (if requested) also contained information on the requirement.
 - Options for licensee with visual impairment who cannot renew online?
Response: The licensee should call 478-207-2440 to request a paper version of the form. This is an option for all licensees.
 - Could licensee request an interview to receive clarification of requirements for application or renewal?
Response: The Board would have to give approval for an interview, with requests to be submitted at least one week before a scheduled meeting to allow time to add to the agenda for Board consideration. Encourage the use of the Board's website to gain clarification on rules and policies.
 - NASW is watching SB 128 relating to revision of definitions relating to marriage and family therapy.
- Tracy Hall, Georgia Licensed Professional Counselors Association (GA LPCA)
 - April 12-13, 2013 Master Therapist Series to be held in Atlanta. Attendees can receive 6 CEs per day.
 - LPCA is watching SB 65 relating to Mental Health.
- Bruce Conn, Georgia Association for Marriage and Family Therapy (GA AMFT)
 - Association is in the process of hiring a new Executive Director
