Attorney General's Report

Daniel Strowe, Assistant Attorney General gave a status and activity report including forty (40) pending cases and three (3) closed cases.

David Jones announced that Senate Bill #195 passed, allowing Barbershops to have more than one apprentice.

Virgil Ergle made a motion, Charles Manning seconded, and the Board voted unanimously to post the following rule change:

70-4-.06 Apprentices.

(1) No master barber may train more than one apprentice at the time. No barber shop shall have in training more than ~~one~~ three apprentices at any time.

(2) A licensed master cosmetologist, hair designer, nail technician, or esthetician shall not train a barber apprentice in a barber shop.

(3) A barber apprentice shall be trained only by a the master barber that he/she is assigned to apprentice under on his/her license.

(4) The master barber shall be present during any services performed by the apprentice in the barber shop.

(5) The barber apprentice may only apprentice at one shop. A new application is required if the apprentice desires to change master supervisor or the shop that he/she is assigned.
