The Board discussed an inquiry from the Georgia Association of Business Tax Officials (GABTO) about serving alcoholic beverages to patrons in Salon/Shop facilities. Board Rule 240-4-.01 (3) and (4) Requirements of Operating a Facility. The Board Rule expressly prohibits activities such as “dining.” Therefore it is the recommendation of the Board that if alcohol is served at a facility licensed by Board, the Salon/Shop must comply with all state and local alcohol requirements of the local jurisdiction(s) of the city or county where the facility is located

and separate food service operations from Salon/Shop operations to prevent the spread of bacteria to patrons through the serving of beverages or food. The best practice implied by the Board Rule is not to offer or serve alcohol at licensed facilities.

Petition to Lift Suspension - CO121238 R.L.W.

David Jones motioned, Virgil Ergle seconded, and the board voted unanimously to accept Petition to Lift Suspension and accept new Consent Order by 12/19/16 pending receipt of all documents.

Administrative Licensing Policy regarding fraudulent applications

The Board discussed applications submitted with information that has been determined to be fraudulent. The Board discussed the necessity for Board staff to administratively Deny applications when documentation has been submitted that has been deemed to be fraudulent (identification, verifications, licensure, etc. David Jones motioned, Virgil Ergle seconded and the Board voted unanimously to update the Board's Administrative Licensing Policy L-1 to add the following:
