CORRESPONDENCE

The Board did not receive any correspondence from the public.

EXECUTIVE DIRECTOR REPORT

- **Florida Board of Cosmetology and Barbers Request for Information**
Executive Director Chris Jones received a request from the Executive Director of the Florida Board of Cosmetology and Barbers for application information regarding applicants that were denied by the Georgia State Board of Cosmetology and Barbers due to fraudulent documentation submitted. Virgil Ergle made a motion, David Jones seconded, and the Board voted unanimously to release the requested information to the Florida Board, and to maintain a record of all information released.
- **Elaine Sterling Institute**
Executive Director Chris Jones discussed a letter from the US Department of Education stating that Elaine Sterling Institute has been released from the Agency's Zone Alternative restrictions. For-profit and non-profit schools who participate in Federal Student Aid programs must be audited by the US DOE yearly to assess the school's financial responsibility and to assure that the school is meeting all its financial obligations.

- **Open Records Request**

Executive Director Chris Jones presented and Open Records Request from Shamim Akhtar. The former applicant requested for any original documents submitted during the initial application be returned. Due to the Board's retention schedule, the requested documents are no longer available for release. David Jones made a motion, Sarah Scott seconded, and the Board voted unanimously to release Certified Copies of the electronic records available to Shamim Akhtar.
