**INSPECTIONS REPORT**

The Board reviewed the attached report of Inspections for the month of July. David Jones and Jennifer Cheely seconded, and the Board voted unanimously to accept the Inspections Report for September 2017.

**EXECUTIVE DIRECTOR REPORT**

- Executive Director Chris Jones presented a copy of correspondence dated Sept. 28, 2017 from the US Dept. of Education for the Board’s information regarding the Fayette Beauty Academy. No Board action was required.

Executive Director Chris Jones presented an email from the licensee requesting that the Board dismiss or extend the amount of time to pay a \$500 fine for Unlicensed Practice, issued by the Board at the September 18, 2017 Board Meeting, to be extended to ten (10) months. David Jones motioned, Jennifer Cheely seconded, and the Board voted unanimously to uphold the \$500, and grant petitioner’s request for an extension.

Executive Director Chris Jones presented correspondence from licensee requesting to dismiss a citation because she did not sign the citation the date issued due to being incarcerated. Betty Carlisle motioned, Virgil Ergle seconded, and the Board voted to issue an Order of Dismissal, to be signed with express permission, and to place the applicant’s license and salon application on HOLD due to failure to disclose arrest/criminal charges on her license renewal and her salon application.
- **Application- Artwork Barber Shop**  
Executive Director Chris Jones reminded the Board about the pending appearance in Open Session of the barber shop owner as granted by the Board at the September 25, 2017 meeting.

- **Request for appearance before the Board by T. Jordan**  
Executive Director Chris Jones told the Board about a request received by T. Jordan to appear before the Board regarding her desire to be issued an instructor license. No application for licensure has been received. The Board instructed the staff to schedule an appearance for a future Board meeting.
- **S.W.C. d/b/a S.A.—Move to Executive Session**  
Executive Director Chris Jones presented a request from a licensee requesting a reconsideration or rehearing of the citation case that was heard at the May 22, 3017 hearings in which the Board issued a Final Decision to uphold the citation and impose a \$500 fine. The matter was moved to Executive Session for discussion regarding the case.

Visitors attending the Board’s open session were recognized. The visitors asked the Board about guidelines for on line instruction of students enrolled in cosmetology and barber schools.

**OPEN SESSION APPEARANCES**

**10:33 a.m. Applicant Number 2681057 Prime Time Barbershop — Initial Cosmetology Salon Application for Licensure previously denied by Board.**

Frederick Bush, the owner of the applicant barbershop, appeared with his attorney, Melvin Goldstein. Mr. Goldstein and Mr. Bush presented information to the Board about Mr. Bush’s background as a barber and the history of the Bush family business of owning 17 barbershops in the Metro Atlanta area. A plan was presented for new management of the 17 barber shops, including the barbershop whose application had been denied by the Board, and for hiring graduates of a Board-approved barber school as licensed barbers to work in the shops. Mr. Bush asked the Board to reconsider the denial of the application for licensure of his newest barbershop in light of his proposed management plan and the hiring of recently graduated and licensed barbers to work in the shops he owns.

At the conclusion of the applicant’s appearance, the Board voted to enter into Executive Session.

No votes were taken regarding the appearance by Art Work Barber Shop.
