Licensing Supervisor, Debra Helms discussed with the Board the possibly of changing the Salon/Shop applications for licensure. Further discussion on the matter was postponed to a future meeting.
- **NABBA 2017 Conference Minutes** – Presented for information only. No Board action required.
- **Correspondence** from Federal Student Aid concerning the International School of Skin and Nailcare was presented for information only. No Board action required.
- **Petition for Rule Variance or Waiver Request - L.M.**
The Board reviewed a Petition for Rule Variance or Waiver from L.M. who submitted an application for licensure by endorsement based upon a Nail Tech license from Florida. In the petition, the applicant

requested not to be required to take a practical examination before GA licensure is granted. After discussion, David Jones made a motion, Philamenia Rivers seconded, and the Board voted to deny the petition due to the applicant not meeting the statutory requirements for licensure found in O.C.G.A. § 43-10-9(d)(1) (which requirements cannot be waived by the Board), the provisions of Rule 240-11-01(1)(b)(i) & (ii), and not establishing a substantial hardship as required by O.C.G.A. § 50-13-9.1.

- **Microblading and Dermaplainning discussion.**

Visitors present during open session asked the Board about the use of microblades and the practice of micro needling by licensed cosmetologists in Georgia.
