**Discussion** on proposed rule change to rule 85-1-.05 Arena Security. Vice Chairman Thompson makes a motion to approve as amended and sending to the Attorney General's office for Authority to Post. Chairman Millican seconds, and the Commission votes 5-0 to approve as amended.

**Petition for Rule Waiver** by NFC Fighting. This waiver will allow amateur title bouts to be 5 rounds. Commissioner Traub makes a motion to approve. Commissioner Orlans seconds, and the Commission votes 5-0 to approve.

**Petition for Rule Waiver** by NFC Fighting. This waiver will allow advanced amateur muay thai fighters to wear elbow pads. Vice Chairman Thompson makes a motion to approve. Commissioner Traub seconds, and the Commission votes 5-0 to approve.

**Appeal of Decision** from Yuri Foreman from June 19, 2021. Following hearing statements from Shoshana Foreman, Commissioner Traub makes a motion to deny claiming no blatant fouls causing the Commission to overturn. Vice Chairman Thompson seconds, and the Commission votes 5-0 to deny.

**Appeal of Decision** from Phillippe Gentry from June 25, 2021. Following hearing statements from Phillippe Gentry, no action is needed. Mr. Gentry is going to work with the Executive Director on plans to improve officials.

**Final Discussion** on Tipping Fighters. Chairman Millican ask for the Executive Director to draft two new rules for this topic for the Commission to review. Once reviewed, the proposed rules can be sent over to the Attorney General's office for legal authority review.

**Incident Report** from July 10, 2021. Following hearing the issues, Chairman Millican makes a motion to send official notice of Matters Asserted to hold a hearing on these two fighters. Commissioner Orlans seconds, and the Commission votes 5-0 to send to Attorney General's office.
