Appeal of Decision by Terri Moss from September 16, 2021. After hearing the details on the appeal, Commissioner Traub makes a motion to table to collect more information. Vice Chairman Thompson seconds, and the Commission votes 5-0 to table.

Discussion on Dalton Bodie break of contract from August 21, 2021. After hearing the details on the no show, Commissioner Traub makes a motion to table to invite Mr. Bodie to attend in November. Vice Chairman Thompson seconds, and the Commission votes 5-0 to table.

Discussion with Montreal James from September 25, 2021. After hearing the details on the events that took place, Commissioner Traub makes a motion to send a letter to the promoter to correct the issue prior to the November meeting or the Commission will look to place a claim on the surety bond. Commissioner Orleans seconds, and the Commission votes 5-0.

Discussion on proposed rules change creating a doctor pay scale. The Commission is going to continue to research the topic and will bring a proposed rule change later.

Discussion on contracts and enforceability when fighters don't fulfil obligations. Vice Chairman Thompson ask for this to be reviewed in a legislative subcommittee with the Chairman and Executive Director.

Discussion with Dr. Andrea Hill on boxing matchmaking. Dr. Hill wants to work with the Commission to set a standard for approving matchups or create a penalty system for bad mismatches if they occur on multiple shows from the same promoter.

Commissioner Reynolds left the meeting

Discussion with Johnny Davis of the IKF. Mr. Davis wanted to see about adding a pro bout to an IKF event coming to Columbus in January.

Commissioner Traub left the meeting.
