Public comments were received on Rule 250-5-.09* and Rule 250-6-.07**. No other public or written comments were received by the Committee during the hearing. At the conclusion of the public comment portion, La Trenda Tyler-Jones declared the hearing closed, and the regular meeting of the Committee was called back into Open Session at 11:20 a.m.

The Division Director entertained a motion to accept the Proposed Rules 546-1-.01, 546-1-.02*, 546-1-.03, 546-2-.01, 546-2-.02, 546-3-.01, 546-3-.02, 546-3-.03, 546-4-.01, 546-4-.02, 546-5-.01, and 546-5-.03 (see attached). Wanda Jaffe moved, Doug Deal seconded, and was affirmatively voted by the Committee that the formulation and adoption of the proposed rule amendments does not impose excessive regulatory costs on any licensee or entity, and any cost to comply with the proposed rule amendments could not be reduced by a less expensive alternative that fully
