B. Howard – Unlicensed technicians: Must be supervised by the licensee. The key is “supervised.” It is actually defined. Responsibility of work performed is that of the licensee. Not the technician unless the technician is the licensee.

C. Huffman – installing cat 5 requires license: Camera is part of the security system itself; it is not a stand-alone component. LVU covers all cabling.
