Correspondence:

The Board reviewed and discussed correspondence received from Billy M. Elliott, Jr. A motion was made by Maushardt, seconded by Strickland, and the Board voted to respond to correspondence by informing the individual that the Board does not speculate regarding programs. The Board must have an application from an applicant in order to review the qualifications and the applicant may submit the curriculum with the course including what was taught and how the course work related to the profession of plumbing.

Executive Director's Report:

Deborah Beard, Executive Director informed the Board the late renewal period has closed. She also informed the Board of the PHCC Association meeting held on May 3, 2017 in which her and Lisa Durden, PLB Division Director attended. The Association was provided information about the Board, the application process, how the test are created, and information on the Secretary of State Office.

Beard also discussed with the Board the need for applications to be reviewed in a timelier manner. This will assist Board staff in responding to applicants in a timelier manner and reduce complaints from applicants about the application process. This also allows applicants to be able to receive deficient letters in time to get the deficient information back to the Board prior to board meetings. The 2017 board meetings were moved to about two to three weeks prior to the AMP registration deadline in order to allow the Board and applicants more time to be approved for the exam. As for complaints a timelier response allows staff the ability to respond to complainants inquiring about the status of their complaint.
