The Division was also provided an update on active licensees as of January 25, 2021. There were 1,361 Journeyman Plumber licensees, 621 Master Plumber – Restricted licensees, and 3,685 Master Plumber – Non-Restricted licensees. There are currently 358 applications in process.

Express permission was granted for La Trenda Tyler-Jones to sign documents in the Chair's absence.
