Board Meeting
March 25, 2010

A meeting of The Georgia Board of Private Detective and Security Agencies was held on March 25, 2010 at 237 Coliseum Drive, Macon, Georgia. John Villines, Chairman, called the meeting to order at 9:09 a.m.

A quorum was established with members present being: John Villines, Chairman; Glade Johnson, Vice Chair; Chief Woodrow W. Blue, Jr., Director Vernon Keenan, Robert F. Warner and James “Tripp” Mitchell.

Joe Memolo, Executive Director of EPI – ISPAG; addressed the Board concerning SB162 and the need to revise the Georgia Private Detective and Security Agencies Act. Chairman Villines supported the need to revise the Georgia Private Detective and Security Agencies Act and suggested the task be a collaborative effort among the Board and various professional associations.

Roy Wilkinson, President of GAPPI expressed his views of SB162 to the Board, summarizing it’s possible impact on the industry and detailing , in his opinion, the positive and potentially negative aspects of the legislation.
