## **NURSE LICENSURE COMPACT – NATIONAL COUNCIL OF STATE BOARDS OF NURSING**

Dr. Maryann Alexander, Chief Officer, Regulation, National Council of State Boards of Nursing provided an overview of the National Council of State Boards of Nursing (“NCSBN”) and the support it provides to state boards of nursing. She introduced the Nurse Licensure Compact (“NLC”) and noted that it was one of NCSBN’s primary initiatives. Dr. Alexander gave a PowerPoint presentation that detailed the structure and operation of the NLC and provided information regarding the benefits to Georgia. She provided information regarding the disciplinary process for members of the NLC; the function of the Interstate Commission; the rulemaking authority of the Interstate Commission; and, discussed the difference in material changes to the NLC language versus enabling language used to assist a jurisdiction with implementation of the NLC. Dr. Alexander noted that NCSBN would provide resources to the Board to assist with implementation of the NLC and noted that ten (10) states had passed NLC legislation in 2016 and that eighteen (18) states planned to introduce NLC legislation in 2017.

### **NURSE LICENSURE COMPACT**

Dr. Maryann Alexander, Chief Officer, Regulation, National Council of State Boards of Nursing provided an informational session on the NLC and its benefits for Georgia.

Wendi Clifton, W.L. Clifton Political Consulting / Georgia Nurses Association provided an informational session on the legislative process and how individuals could advocate for the NLC during the 2017 legislative session.

### **Substantive Changes**

#### **Southeastern Technical College**

The Board received notification that Southeastern Technical College had adjusted the credit hours of the associate degree in nursing program from sixty-five (65) to sixty-six (66) hours to be in compliance with Technical College System of Georgia requirements. Based on compliance with Board Rule 410-8-.04, it is recommended that the Board approve the change in curriculum.

### **Georgia State University**

The Board received notification that Melissa Faulkner, RN, PhD., FAAN, had been named Associate Dean of Nursing of the nursing education program at Georgia State University. Based on compliance with Board Rule 410-8-.05 it was recommended that the Board accept the change.

### **Shorter University**

The Board received a substantive change request from Shorter University resulting from (a) recommendations in the 2014 GBON Education Consultant's site visit report, (b) faculty and university concerns about low NCLEX-RN pass rates, and need to complete and submit a self-study to CCNE for the October 2106 site visit.

1. BSN Foundational Core prerequisites increased from 39 to 41 credit hours
2. BSN Nursing Major Courses credit hours reduced from 68 credit hours to 62 credit hours.
3. Students already enrolled in the Brady School of Nursing will follow a teach-out plan to ensure that all content has been covered based on changes in the curriculum.
4. The incoming junior cohort will follow the new curriculum plan

Based on compliance with Board Rule 410-8-.04, it is recommended that the Board approve the change in curriculum.

### **Developing Programs**

#### **Central Georgia Technical College**

A site visit was conducted on September 30, 2016 to the main campus of Central Georgia Technical College. The program plans to enroll thirty (30) students and begin classes on January 5, 2017. All requirements of Board Rule 410-8-.10 were fulfilled and it is recommended that the Board continue initial approval of the associate degree in nursing program.

#### **Gordon State College**

Gordon State College has submitted a letter of intent, and reports 1 and 2 for the development and implementation of a proposed bachelor of science in nursing program.

1. Received Report 1 for development and implementation of a proposed Bachelor of Science in Nursing Program. Letter of Intent and Reports 1 & 2 were received on 11/6/15. The Nursing Program already has ASN and RN-BSN programs.
2. Documents not received in Report 2 (course syllabi, program and college catalogs) were received on 9/23/16.
3. The Board of Trustees approved the Feasibility Study which is comprehensive, thorough, and addressed requirements of [Rule 410-8-.12 (1a-k)]. The proposed time for implementation of the program in Report 1 was Fall Semester 2016.
4. Report 1 presents excellent rationale for adding a BSN program which included national and local emphasis on increasing the RN workforce to 80% BSN graduates by 2020. Gordon State plans to decrease admissions to its ASN program as the BSN program is implemented noting that Southern Crescent Technical College in Griffin has been approved for development of a ASN program
5. The Gordon State College of Nursing currently has 20 FT faculty plus the Dean. Six of the faculty members have doctoral degrees, 2 faculty who are in the dissertation phase of their doctoral programs and 2 other faculty members who began doctoral programs in 2015.

Based on compliance with Board Rule 410-8-.12 it is recommended that the Board grant initial approval to this program.

#### **Oconee Fall Line Technical College**

Oconee Fall Line Technical College has submitted a letter of intent, and reports 1 and 2 for the development and implementation of a proposed associate degree in nursing program.

1. Submitted Feasibility Study (Report 1) for the development of a Practical Nursing (LPN) and Paramedic to Associate Degree in Nursing (ADN Program). Darton State College which has offered a very successful LPN/Paramedic to ADN bridge program on OCFTC's Sandersville Campus since 2009 will be closing the program due to its mandated consolidation with Albany State University. Darton State College has asked for OFTC's assistance in continuing ADN education in the east central area of the state.

2. Darton faculty who have been teaching in the ADN bridge program on the OCFTC's Sandersville Campus have expressed that they want to continue teaching the program.
3. OCFTC in Sandersville will take over the Darton building on their campus.
4. Report 1 is well written and covers all requirements of Rule 410-8-12(1a-k)

Based on compliance with Board Rule 410-8-.12 it is recommended that the Board grant developmental approval to this program.

### **Wiregrass Georgia Technical College**

Wiregrass Georgia Technical College graduated its first cohort in May 2015. The 2015 NCLEX pass rate was 95.24%. The 2016 year to date pass rate is 100%. Based on compliance with Board Rule 410-8-.02, it is recommended that the Board grant full approval to the associate degree in nursing program.

### **Continuing Approval**

#### **Columbus Technical College**

The approval has expired for the associate degree in nursing education program at Columbus Technical College. The four year NCLEX pass rate is 95.11%. The 2016 year to date pass rate is 96.97%. It is recommended that the Board extend approval through December 31, 2025.

#### **Southern Regional Technical College**

The practical nursing education program at Southeastern Technical College is approved through December 31, 2016. The four year NCLEX pass rate is 84.03%. The 2016 year to date pass rate is 90.24%. It is recommended that the Board extend approval through December 31, 2020.

Rowe seconded the motion and it carried unanimously.

## **STRATEGIC PLAN – REVIEW POLICY RELATING TO NURSES EVACUATING WITH PATIENTS DUE TO HURRICANE MATTHEW**

The Board reviewed the policy adopted October 6, 2016 to allow nurses evacuating with patients to Georgia due to Hurricane Matthew. The Board reviewed the 2004 policy for out of state nurses practicing in Georgia during a time of emergency/disaster. Carole Jakeway, District and County Operations Director, Georgia Department of Public Health, provided information regarding the 2004 policy. She noted that the Department of Public Health (DPH) provided the majority of nurses for evacuation shelters during times of emergency and disaster. She expressed interest in the Nurse Licensure Compact and the positive impact it would have to allow nurses to cross state lines to practice.

Izlar thanked Jakeway for the information and explained that the Board would review the language on Friday, November 18, 2016.

## **EDUCATION REPORT**

### **Thomas University**

The Board reviewed documentation from Thomas University regarding a post licensure nursing education program for international students. Thomas University was seeking the Board's guidance regarding whether or not the international students would need to be licensed in Georgia. Dr. Nadine Connor, Dean, Thomas University, provided an overview of the program.

Izlar thanked Dr. Connor for the information and explained that the Board would review the issue on Friday, November 18, 2016.

## **STRATEGIC PLAN – REVIEW OF MENTAL PHYSICAL EXAMINATION PROVIDERS**




