The motion passed unanimously.

CASE REVIEW (Legal and Discipline cases)


(RNI=Registered Nurse Investigative Case Number, LPNI=Licensed Practical Nurse Investigative Case Number)

LPNI150442 – Barton moved to rescind the previous motion from October 16, 2017 and refer to the Attorney General's Office for an intensive inpatient evaluation. Fort seconded the motion and it carried unanimously.

**AFFIDAVIT SUPPORTING CLOSING OF


