


LPNI180040 – Train moved to refer to the Attorney General’s Office for a summary suspension. Fort seconded the motion and it carried unanimously.

**AFFIDAVIT SUPPORTING CLOSING OF

The Georgia Open Meetings Act, O.C.G.A. § 50-14-1 *et seq.*, requires that all meetings of an entity covered by the statute must be open to the public unless there is some specific statutory exception which permits the closing of the meeting. 
Comes now the presiding officer identified below and, before an official duly authorized to administer oaths, makes this affidavit in satisfaction of the statutory requirements outlined above.
