Hooper called the meeting to order at 4:00 p.m. on Thursday, April 19, 2018.

### **EXECUTIVE SESSION**

Bryant moved, Floyd seconded and the Committee voted to enter into **Executive Session** in accordance with O.C.G.A. §§ 43-1-2(k); 43-1-19(h), 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative reports and pending cases. The motion passed unanimously.

At the conclusion of the Executive Session on Thursday, April 19, 2018, Hooper declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. §§ 50-14-1 et seq. No votes were taken during Executive Session.

May petition to lift with mental physical examination from a Board approved evaluator completed within thirty (30) days of petition.

**RNI170163** – Refer to the Attorney General's Office for a public consent order to include five (5) years probation, two (2) years narcotic restrictions, quarterly reports (self, employer, aftercare, psychotherapy with addictionologist), quarterly hair follicle tests for twelve (12) months, and urine drug screens, Substance Abuse Stipulations, and a course in Understanding Substance Use Disorder in Nursing.

**RNI180728** – Refer to the Attorney General's Office for a private consent order to include two (2) years monitoring, quarterly reports (self, employer, psychotherapy), Substance Abuse Stipulations and a course in Understanding Substance Use Disorder in Nursing. Continue with psychotherapy and counselor from Avita.

**LPNI110439** – Refer to the Attorney General's Office for a public consent order to include three (3) years probation, quarterly reports (self, employer, aftercare) quarterly hair follicle tests for twelve (12) months, urine drug screens throughout the order, Substance Abuse Stipulations and a course in Understanding Substance Use Disorder in Nursing.

**RNI180323** – Refer to the Attorney General's Office for a private consent order to include five (5) years monitoring, two (2) years narcotic restrictions, quarterly reports (self, employer, aftercare, psychotherapy, medication management), monthly PEth for twelve (12) months, quarterly urine drug screens hair follicle tests for twelve (12) months, and urine drug screens, Substance Abuse Stipulations, a course in Understanding Substance Use Disorder in Nursing, Naltrexone Statement and complete 12 step meetings in 90 days (must enroll within 30 days of order).

**RNI181151** – If records from Talbot are not received within 30 days, refer to the Attorney General's Office for an expedited outpatient mental physical examination from a Board approved evaluator. Results are to be reviewed by the Investigative Committee and the Legal/Discipline Nurse Consultant. If non-compliant, refer for a voluntary surrender or indefinite suspension and deny the renewal. May petition to lift with mental physical examination from a Board approved evaluator completed within thirty (30) days of petition.

**RNI181157** – Send a letter of modification with a new sobriety date of March 3, 2018. Continue in Georgia Recovery Treatment Plan.

**RNI170526** – Table pending receipt of final disposition. Review again at May 16-18, 2018 Board meeting.

**RNI171092** – Refer to the Attorney General's Office for a public reprimand to include a fine of \$500 for Action in Another Jurisdiction.

**RNI180174** – Table until May 16-18, 2018 Board meeting.

**RNI170689** – Refer to the Attorney General's Office for an expedited outpatient mental physical examination from a Board approved evaluator. Results are to be reviewed by the Investigative Committee and the Legal/Discipline Nurse Consultant. If non-compliant, refer for a voluntary surrender or indefinite suspension and deny the renewal. May petition to lift with mental physical examination from a Board approved evaluator completed within thirty (30) days of petition.

**RNI181196** – Send the applicant a letter requesting an outpatient mental physical examination from a Board approved evaluator as a consideration of the application. Results are to be reviewed by the Investigative Committee and the Legal/Discipline Nurse Consultant.

**LPNI150466** – Close the case.




**Comes now the presiding officer identified below and, before an official duly authorized to administer oaths, makes this affidavit in satisfaction of the statutory requirements outlined above.**
