Worthy called the meeting to order at 4:00 p.m. on Thursday, May 3, 2018.

EXECUTIVE SESSION

Blalock moved, Barton seconded and the Committee voted to enter into **Executive Session** in accordance with O.C.G.A. §§ 43-1-2(k); 43-1-19(h), 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative reports and pending cases. The motion passed unanimously.

At the conclusion of the Executive Session on Thursday, May 3, 2018 Worthy declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. §§ 50-14-1 et seq. No votes were taken during Executive Session.

RNI108472 – Refer to the Attorney General’s Office for a private consent order to include five (5) years probation, narcotic restriction, quarterly reports (self, employer, aftercare, psychotherapy, medication management), quarterly hair follicle tests for twelve (12) months (include EtG and EtS), urine drug screen throughout the order, Substance Abuse Stipulations, Substance Use Disorder in Nursing and Naltrexone statement and a fine of \$500 for Failure to Disclose.

Results are to be reviewed by the Investigative Committee and the Legal/Discipline Nurse Consultant. If non-compliant, refer for a voluntary surrender or indefinite suspension and deny the renewal. May petition to lift with submission of mental physical examination.

RNI170673 – Refer to the Attorney General’s Office for a voluntary surrender or indefinite suspension. May petition to lift with documentation of completed treatment (IOP and random drug testing) and safe to practice statement.

RNI170688 – Refer to the Attorney General’s Office for a public reprimand consent order to include five (5) years probation, two (2) years monitoring, quarterly reports (personal, employer, aftercare, psychotherapy) quarterly hair follicle testing with EtG, and EtS for twelve (12) months and drug screens throughout the order, Substance Abuse Stipulations and a course in Substance Use Disorder in Nursing.

LPNI180170 – Refer to the Attorney General’s Office for an expedited outpatient mental physical examination from a Board approved evaluator. Results are to be reviewed by the Investigative Committee and the Legal/Discipline Nurse Consultant. If non-

compliant, refer for a voluntary surrender or indefinite suspension and deny the renewal. May petition to lift with submission of mental physical examination.

RNI170762 – Turn on Nurse Alert in NURSYS.

RNI170708 – Refer to the full board for discussion.

LPNI170224 – Send an investigative letter requesting courses in Professional Accountability and Legal Liability for Nurses, Documentation: a Critical Aspect of Care and Ethics of Nursing Practice.


RNI170773 – Refer for an Investigative Interview.


**AFFIDAVIT SUPPORTING CLOSING OF
PUBLIC MEETING**

The Georgia Open Meetings Act, O.C.G.A. § 50-14-1 *et seq.*, requires that all meetings of an entity covered by the statute must be open to the public unless there is some specific statutory exception which permits the closing of the meeting. If such a meeting is to be closed, the law requires that the presiding person execute a sworn affidavit stating that the subject matter of the meeting or the closed portion thereof was devoted to matters within the statutory exceptions and identifying those specific exceptions relied upon. O.C.G.A. §50-14-4(b). A copy of this affidavit must be filed with the minutes of the meeting in question.
