EXECUTIVE SESSION

Train moved, Fort seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§43-1-2(k); 43-1-19(h); 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative cases and pending cases. The motion passed unanimously.

At the conclusion of the executive session on Monday, September 30, 2019, Izlar declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. § 50-14-1 et seq. No votes were taken during executive session.

RNI181253 – Train moved to refer to the Attorney General’s Office for a summary suspension. May petition to lift with completion of treatment program, safe to practice statement from addictionologist and standard practice requirements. Bryant seconded the motion and it carried unanimously.

RNI200224 – Fort moved to refer to the Attorney General’s Office for a summary suspension. May petition to lift with an outpatient mental physical examination to include a safe to practice statement and standard practice requirements. Results are to be reviewed by the Investigative Committee and the Legal/Discipline Nurse Consultant. Thompson seconded the motion and it carried unanimously.



**AFFIDAVIT SUPPORTING CLOSING OF

The Georgia Open Meetings Act, O.C.G.A. § 50-14-1 *et seq.*, requires that all meetings of an entity covered by the statute must be open to the public unless there is some specific statutory exception which permits the closing of the meeting.
