Misc. Discussion Items:

- PLB Legal Section – Joint Secretary Rule 295-2-.13(c)

Presented by J. Uzzo, Esq., the Division Director has proposed amendments to the rule on expiration and renewal dates, specifically with regard to the lapsed-late renewal period. The proposed amendment would give all professional licensing Boards served administratively by this office the same one month lapsed late renewal period as opposed to, in this Boards rules, a three month period. The Board unanimously agreed to the proposal, and to also amend their current rules reflecting this three month period as well.

Ms. Hudson motioned, Ms. Schultz seconded, and the Board voted to approve proposed changes to Rule 295-2-13(c) as presented. None opposed, motion carried.

With no further discussion required, the Board meeting adjourned at 12:43 p.m.
