OPEN SESSION – 9:14 a.m.

CALL TO ORDER: Jason Reaves, Chairman, noted that a quorum was present, called the meeting to order at 9:14 a.m., and declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. §§50-14-1 et seq.

APPROVAL OF AGENDA

David Johnson made a motion, Matthew Cristy seconded, and the Board voted unanimously to approve the September 18, 2019 Agenda.

OPEN SESSION OTHER BUSINESS REPORT

The Board continued to review the Open Session Other Business Report as presented by Executive Director Chris Jones. David Johnson made a motion, Matthew Cristy seconded, and the Board voted unanimously to accept the following recommendations regarding the Open Session Other Business Report.

Board Discussion – Adjusting Lapsed-Late Renewal Period: Staff Attorney, Jessica Uzzo addressed the Board requesting a recommendation to adjust the Joint Secretary Rules as it pertains to the Lapsed-Late Renew period for all license types. The Administration is requesting for all Boards to be consistent and have a thirty (30) day Lapsed-Late renewal period. David Johnson made a motion, Matthew Cristy seconded, and the Board voted unanimously to approve the recommendation.
