

**Minutes Of The Used Motor Vehicle Parts Dealers Division
April 6, 2006**

The Used Parts Division of the Georgia State Board of Registration of Used Motor Vehicle Dealers and Used Motor Vehicle Parts Dealers held its regular meeting on April 6, 2006, at 237 Coliseum Drive, Macon, Georgia. Robert Griggers, Chairman, called the meeting to order at 10:05AM.

Mr. Hooper made a motion, based on the expertise of the Board Office staff, to ask them to administratively approve used parts applications which meet all requirements for licensure and issue the license before the May Meeting. Any questionable applications would be presented at the Board Meeting. Mr. Cronan seconded the motion. The motion carried.

Given the full Agenda for the upcoming meeting, it was the Board's decision to schedule Bobby's Junkyard appointment for the July 6, 2006 Board Meeting.

The Board discussed zoning. Mr. Lindsey informed members that there has been some change in the language for the zoning page in the Used Parts application. While counties have welcomed this beneficial document, he continues to work with Dekalb and Fulton counties on precise used parts and used car definitions to make it easy for everyone responding.

Mr. Lindsey informed the Board that the Enforcement Section has requested to conduct an inspection of the established place of business before applications are approved. These pre-inspections could help ensure compliance with signage and other requirements. Mr. McLeod made a motion to approve pre-inspections. Mr. Cronan seconded the motion. The motion carried.

There being no further business, the meeting adjourned at 11:50 AM.
