Other Business:

Steve Lindsey informed board members of the upcoming changes for processing fingerprints for Georgia applicants that require a criminal history background check. The applicant must register for electronic submission of fingerprints through the Cogent Systems website.

State Agencies will be able to go through the Georgia Application Processing Services (GAPS) to obtain background information results. The Secretary of State is the first agency authorized by Cogent Systems and GBI as a Reviewing Agency with GAPS. GAPS is totally electronic and will replace the need for applicants to submit paper fingerprint cards.
