

**Georgia State Board of Registration of
Used Motor Vehicle Parts Dealers
Board Meeting
June 4, 2015**

Public Hearings:

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Parts Dealers on June 4, 2015, for the purpose of hearing allegations that, if proven, may result in disciplinary action against the licensee, including the revocation of their license. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Robert Griggers, called the hearings to order at 10:013 a.m. A quorum of the Board was established with members Robert Griggers, Chairman; Eugene (Gene) Sapp, Sidney McLeod, Michael Rosser, and Douglas Hooper with the Georgia Department of Revenue. At the conclusion of the hearings, the Board rendered the following decisions on each case:

Quality Body Shop: Sidney McLeod moved, Michael Rosser seconded, and the Board voted to Refer to Attorney General's Office for revocation.
