#### Discussion - Board Rule 700-7-0.1-.03 Emergency Rule on Continuing Veterinary Education

Upon finding that the coronavirus pandemic is of imminent peril to the public health, safety, and welfare; and, upon Governor Kemp's Executive Order declaring a public health emergency in the state of Georgia; and based upon the fact that in-person continuing education seminars have been canceled leaving little time for licensees to meet renewal requirements, Dr. Bohn motioned, Dr. Malphus seconded and the Board voted unanimously in favor of the motion to adopt Board Rule 700-7-0.1-.03 Emergency Rule on Continuing Veterinary Education as presented below and promptly refer the amendment to the Governor's Office for review.

The formulation and adoption of this rule does not impose excessive regulatory cost on any licensee; and any cost to comply with the proposed rules cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A. §§ 43-1-25, 43-50-2, 43-50-21, 43-50-40, 43-50-52. Additionally, it is not legal or feasible to meet the objectives of O.C.G.A. §§ 43-1-25, 43-50-2, 43-50-2, 43-50-21, 43-50-40, 43-50-52 to adopt or implement differing actions for businesses as listed in O.C.G.A. § 50-13-4(3)(A), (B), (C), and (D). The formulation and adoption of this rule will impact every licensee in the same manner and each licensee is independently licensed in the field of veterinary medicine.

# Rule 700-7-0.1-.03. Emergency Rule on Continuing Veterinary Education

Due to the State of Emergency regarding COVID-19, licensees who apply to renew licenses expiring December 31, 2020, may obtain all continuing education hours online in order to satisfy the continuing education requirements outlined within Rule 700-7-.03.

# **Executive Director's Report – A. Price**

Dr. Bohn motioned, Mr. Culpepper seconded and the Board voted unanimously in favor of the motion to accept the Executive Director's report as presented and requested that GVMA attempt to respond to Ms. Price's request for a cost analysis associated with a veterinarian implementing the bill.

#### Discussion - VCPR in Board Rule 700-8-.01(d)(2)(i)

Upon finding that the coronavirus pandemic is of imminent peril to the public health, safety, and welfare; and, upon Governor Kemp's Executive Order declaring a public health emergency in the state of Georgia; and based upon the and the fact that shelter-in-place mandates and recommended safety precautions for immunocompromised clients may make it unfeasible for the client to bring their animal patient to the veterinarian for an annual examination, Dr. Bradley motioned, Dr. Bohn seconded and the Board voted unanimously in favor of the motion to adopt Board Rule 700-8-0.2-.01 Emergency Rule on Unprofessional Conduct as presented below and promptly refer the amendment to the Governor's Office for review.

The formulation and adoption of this rule does not impose excessive regulatory cost on any licensee; and any cost to comply with the proposed rules cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A. §§ 43-1-25, 43-50-2, 43-50-21, 43-50-40, 43-50-52. Additionally, it is not legal or feasible to meet the objectives of O.C.G.A. §§ 43-1-25, 43-50-2, 43-50-2, 43-50-21, 43-50-40, 43-50-52 to adopt or implement differing actions for businesses as listed in O.C.G.A. § 50-13-4(3)(A), (B), (C), and (D). The formulation and adoption of this rule will impact every licensee in the same manner and each licensee is independently licensed in the field of veterinary medicine.

# Rule 700-8-0.2-.01. Emergency Rule on Unprofessional Conduct.

During the State of Emergency regarding COVID-19 and up to 120 days thereafter, Rule 700-8-.01(d)(2)(i)'s requirement that a veterinarian has examined the animal within the last twelve (12) months in order to establish a VCPR, shall be extended to a period of eighteen (18) months. The remainder of the rule shall remain in effect.
