The repeal of this rule will impact every licensee in the same manner and each licensee is independently licensed in the field of Veterinary Medicine.

Mr. Culpepper motioned, Dr. Bradley seconded and the Board voted unanimously in favor of the motion to send the Memoranda of Authority provided by the Attorney General's Office with the rules adopted today to the Governor's office for oversight.
