**OPEN SESSION:**

**Public Hearing:**

A public hearing was held at 1:05 p.m. for the purpose of allowing public comment on proposed rule amendments to Rules 295-2-.06, 295-15-.18, and 295-15-.19. No public or written comments were received by the Committee during the hearing. At the conclusion of the public comment portion, La Trenda Tyler-Jones declared the hearing closed, and the regular meeting of the Committee was called back into Open Session.

**Open Session:**

La Trenda Tyler-Jones entertained a motion to accept the amendments to Rules 295-2-.06, 295-15-.18, and 295-15-.19. Wanda Jaffe moved, Laurie Elander seconded, and was affirmatively voted by the Committee that the formulation and adoption of these rule amendments does not impose excessive regulatory cost on any licensee or entity, and any cost to comply with the proposed rules cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A. §§ 43-1-4 and 43-1-22. 
