Bryant called the meeting to order at 4:00 p.m. on Thursday, June 16, 2022. A quorum to conduct disciplinary matters was determined to exist.

EXECUTIVE SESSION

Thompson moved, Batson seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§43-1-2(k); 43-1-19(h); 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative cases and pending cases. The motion passed unanimously.

At the conclusion of the Executive Session on Thursday, June 16, 2022, Fort declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. §§ 50-14-1 et seq. No votes were taken during executive session.

RNI220339 – Tanner moved to Refer to SOS Investigations to identify the patient’s name in the malpractice report from Respondent and obtain patient’s OB medical records where Respondent treated the patient. Investigations to also obtain the name of the facility that cared for her during her pregnancy termination and obtain those medical records also. Refer records for peer review. Pierce seconded the motion and it carried unanimously.
