<u>Act 813 (HB 972) – New Law effective July 1, 2022 - Specifically Counselors licensure requirement changes:</u>

HB972 (Act 813) was signed into law by Governor kemp with an effective date of July 1, 2022. O.C.G.A. § 43-10A-11 contained two major changes - the requirement of the master's degree program being a minimum of 60 Semester or 80 Quarter hours, and a two-year post-masters directed work experience under supervision. There are numerous APC license holders in various stages of completion of a three-year DWE under Supervision, and who may or may not have a degree program consisting of the now minimum 60/80 hours as notated above.

Executive Director Zimmerman, with the Board's legal counsel's assistance, will prepare a policy for the Board to consider adopting to resolve this matter the best way possible. Subsequent meetings will be convened until something is in place.

Also contained within the new statutory language is a reference to the required course related to diagnosis. It is the position of the Board that effective July 1, 2022, all licenses issued after April 26, 2006 must have completed a graduate level course or equivalent related to diagnosing to renew or apply for licensure.

None opposed, motion carried.

With no additional Board business requiring discussion, the Board meeting was adjourned at 1:55 p.m.
