#### **OPEN SESSION**

Bryant called the meeting to order at 10:05 a.m. on Wednesday, September 14, 2022. A quorum to conduct disciplinary matters was determined to exist.

#### **EXECUTIVE SESSION**

Batson moved, Porter seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§ 43-1-2(k); 43-1-19(h), 43-26-5(c) and 43-26-11, to deliberate on the Agency Review. The motion passed unanimously.

At the conclusion of the executive session on Wednesday, September 14, 2022; Bryant declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. §§ 50-14-1 et seq. No votes were taken during executive session.

On August 31, 2022, Mr. Jason Tanner, Executive Vice President for Instruction notified the Georgia Board of Nursing that Dr. Quetina Pittmann-Howell Dean of Nursing had resigned effective July 31. Ms. Kimberli Roberts PhD(c), RN, CNL, PMC-NE has agreed to serve as interim Dean of Nursing. Ms. Roberts has taught nursing for eight years in ASN and PN programs.

Mr. Jason Tanner also shared with the board an update on the SREB pathway. "About 1 week after our K12 partners came to campus in March 2020 to have Social Sciences, Math, English, and Science faculty from k12 and Chattahoochee plan best pathways and prep for these students, we all became 100% online on 3/13/2020. When registration began a month later for a Fall that was truly an unknown in April 2020, they had lost Hiram and they have not had a Marietta student complete CNA regardless of whatever else was completed (or not) in 2 years now. By year 2 when things were back on campus and as planned, they were down to 8 students staring Anatomy lecture and lab in the face. One from each school made it through the pathway, both with excellent grades and more credits than the pathway prescribed (more than the 30 hours covered by the legislation) and one with a CNA certificate. Student Cohort #1 Spring 2020: 28\* students identified for pathway Marietta (18), McEachern (11) Fall 2020: 18 enroll @ Chattahoochee Technical College Marietta (11), McEachern (7) Spring 2021: 14 students enrolled Marietta (7), McEachern (7) Fall 2021: 8 enrolled Marietta (4), McEachern (4) Spring 2022: 2 students enrolled Marietta (1), McEachern (1) \*Hiram High School did not participate in nursing pathway 7 McEachern Students completed NAST1100 (CNA), 0 Marietta.

In addition Chattahoochee Tech College did not admit a cohort for Fall 2022 secondary to loss of faculty.

Education – 06 – South College – Atlanta - Full Approval Request

**South College (EDUCATION 06)**

Dr. Trina Rodgers, PhD, RN, Associate Dean of Nursing, requests granting of Full Approval of the BSN program based on the current NCLEX-RN year- to-date pass rate of 86.84% and an overall NCLEX -RN first time pass rate of 82.02% for the first three graduating cohorts (since January 2021). Once Full Approval is achieved, South College will offer quarterly admission. They have qualified faculty who are engaged in teaching and evaluation in classes, simulated settings, and practice settings who can support additional admissions and we have secured adequate practice settings to accommodate additional cohort starts. At present they have a total of 12 full time nursing faculty and hiring is ongoing. Their program is six quarters. They plan to admit 80 students each quarter with a goal to help student be successful. They have also hired a support specialist.

According to Board Rule 410-8-.02(2) (d) The Board may grant Full Approval to a nursing education program with Initial Approval when review of the most recent annual report, the most recent site visit report, and program responses to it document compliance with the rules. At least eighty (80) percent of all graduates must pass the licensing examination as first-time writers within one (1) calendar year of the graduation date.

I recommend acceptance of this administrative change notification and a site visit.

Education – 07 – Southeastern Technical College- Revision of Master Curriculum Plan

#### **Southeastern Technical College (EDUCATION 07)**

On August 30, 2022, Ms. Jennifer Corner, MSN, RN, Director for ASN and PN Programs, notified the board that during review of the Master Curriculum Plan (MCP), a calculation errors in the COLL 1040 (institutional credit) course clock hours were identified, The Fall and Spring semesters MCP 's need modification to ensure that they both reflect the same theory (768.75 hours) and clinical clock hours (487.5). The PN Program would like to request the Board's approval of the following MCP revisions – 1) Fall Semester MCP, move PHSG 2340 Med Surgical Nursing IV Clinical from summer to spring semester and 2) Fall Semester and Spring Semester MCPs, change to reflect 768.75 theory clock hours and 487.5 clinical clock hours. Nothing changed in spring, the only thing that changed was the clock hours for COLL 1040. There was a typographical or calculation error. The Fall admission cohort for the summer semester they would like to move the MSIV clinical class from summer to spring secondary to short summer semester that includes a 3–4-day Live Review for the NCLEX-PN. **According to Board Rule 409-9-.12(2)(h) Proposed Program Change notification are to be submitted to the board within (30) days as provided in Rule 410-9-.13. I recommend acceptance of this substantive change.**

Education – 8 – West Georgia Technical College- LPN to RN Bridge

#### **West Georgia Technical College (EDUCATION 04B)**

On August 24, 2022, Sheila Mayfield, MSN, RN Associate Degree Nursing Program Director notified the board regarding their interest in starting an LPN to ADN Associate Degree Program. It is designed to provide an opportunity for Licensed Practical Nurses to earn an Associate Degree in Nursing (ADN). Graduates are then eligible to apply to take the National Council Licensure Examination for Registered Nurses (NCLEX-RN). Upon successful completion of the NCLEX-RN and licensure by the Georgia Board of Nursing, graduates are employable as Registered Nurses. **According to Board Rule 410-8-.11(2) all programs must submit a report of all substantive changes. See documentation in the board packet on the Bridge.**

**I recommend acceptance of this substantive change/notifications.**

Education – 09 – A - Wiregrass Technical College - Change in Leadership

#### **Wiregrass Technical College (EDUCATION 09A)**

On August 15, 2022, Stevan Van Hook, MSN, RN Dean of Academic Affairs- Health Sciences notified the board that the Director of the ASN program, Darlene Ridley, retired as of July 31, 2022. Ms. Georgianne Bauer MSN, RN

is a current ASN program faculty member and is considering application for the permanent position. Her present appointment is interim, as applications for the permanent position have not been obtained. The permanent position of Director of ASN will be filled once qualified applicants are obtained and the interview and hiring processes are complete. Ms. Georgianne Bauer MSN, RN has been working as full-time faculty at Wiregrass Technical College for four years and has 14 years of experience as an adjunct clinical faculty at Valdosta State College. **According to Board Rule 410-8-.11(2) all programs must submit a report of all substantive changes and Board Rule 410-8-.03 (3) The Board must be notified within 30 days of a change in the nurse administrator. See documentation in the board packet on the Bridge including her resume.**

Education – 09 – B - Wiregrass Technical College - Increase in Enrollment Letter and Satellite Campus

**Wiregrass Technical College (EDUCATION 09B)**

On August 2, 2022, Stevan Van Hook, MSN, RN Dean of Academic Affairs- Health Sciences notified the board that they are requesting to offer the generic ASN program option at their Ben Hill/Irwin and Coffee County campus locations. They intend to accept 30 students at these off-campus locations, thus increasing their enrollment by more than 25%. Please note in the substantive change that they intend to enter one generic cohort of 30 students every Fall semester with the off-campus location alternating between the Ben Hill/Irwin and Coffee campus locations with each entry cohort. **According to Board Rule 410-8-.11(2) all programs must submit a report of all substantive changes. See documentation in the board packet on the Bridge.**

**I recommend acceptance of this substantive change/notifications.**

Education – 10 - Augusta Technical College – Off Site Instructional Site

**Augusta Technical College (EDUCATION 10)**

On September 9, 2022. Dr. Ebony Story, DNP, MSN, sent an email to the board regarding establishing an offsite instructional site for the PN and ADN programs. Augusta Technical College has been offered a partnership with Piedmont Augusta to lease 2 floors in their hospital and 2 floors of the hospital medical office building to train Allied health Professionals. This partnership will allow Augusta Technical College to help decrease the nursing shortage in our area. The new location is less than 8 miles away from the current location and will not cause hardship for students. This new location will allow the program to increase enrollment and add a PN to RN option. The location will provide a total of 12 classrooms, a resource center for students, a computer lab, a student lounge, and a campus bookstore. The nursing program will have a dedicated floor and space in the newly renovated ICU, in the hospital for lab and simulation. The floor is roughly 20,000 square feet of lab and clinical space. We will have roughly 20 fully equipped hospital rooms with two nursing stations plus computers. The floor plans are included to show the hospital wing as well as the classroom setting in the medical office building. There are also 4 dedicated ICU bays that nursing will utilize. The address of the off-campus instructional site will be 2260 Wrightsboro Rd. Augusta Ga 30904 in the Piedmont Augusta Summerville Hospital Campus. The nursing program will offer 100% of the nursing curriculum at this off-campus instructional site. Prerequisites will continue to be offered on the main campus and online. This campus has been approved by SACSCOC and ACEN.

The new site is approximately 8 miles away from the current site but will afford more space for the lab and clinical preparation of our students. The programs will continue to deliver a face-to-face format with no changes to the didactic or lab hours or credits. The program is currently gaining six shared clinical faculty for both programs that are being furnished by our partnership with Piedmont Hospital Augusta. They plan to relocate on December 1, 2022, during the semester break so that students will return to the new campus in the Spring.

**I recommend acceptance of this substantive change/notification.**

Education – 11 – Southern Regional Technical College – Revision of PN Plan of Action

**Southern Regional Technical College (EDUCATION 11)**

Ms. Athalena Benton, MSN, RN Director of the ADN and PN programs shared the updated, revised 2022 Plan of

Action. These include 1) Implementation of the TEAS Admission Exam -score of 56% on the admission exam for entry into the PN program, 2) GPA of 2.5, 3) ATI Testing and Review Program, 4) A remediation process for module exams and final exams will be incorporated with active remediation conducted by the student and monitored by the faculty/ remediation coordinator, 5) Drug Calculation Progression Exam with three attempts to score a 100 in the first semester of the nursing program Intro to Pharmacology/ Clinical Calculations (PNSG 2010) and in the last semester Nursing Leadership course (PNSG 2410), 6) Revise PN state standards to reflect the changes of the NCLEX NGN test plan, 7) Implementation of a NCLEX review with new ATI testing product, 8) Provide a comprehensive mentoring process to faculty who have been employed less than two years in PN Program. **According to Board Rule 410-9.03(2)(b) The program must respond in writing to the Board's recommendations and suggestions within six (6) weeks of receipt of the notification and must include a plan of action to correct the cited deficiencies. The plan of action should be implemented immediately by the program. Rule 410-9.03(4) If the deficiencies have not been corrected within one (1) year from the date of Conditional Approval status notification, the program's approval status shall be Withdrawn. See documentation in the board packet on the Bridge.**

## **Program Approval**

### **Education – 12 – South University – New Program**

#### **South University (EDUCATION 12)**

On August 25, 2022, Dr. Alexis Best-Rhodes, PhD, RN, BSN Program Director at South University, Savannah, GA submitted an application to the Board to establish a pre-licensure BSN program at the Savannah campus of South University. South University is currently an eight-campus system accredited by the Commission on Colleges, Southern Association of Colleges and Schools (SACSCOC). The institution's accreditation was reaffirmed in 2014 for ten years. The Savannah, GA campus is the largest campus and is the main campus of the University. Other campuses are in Austin, TX, Columbia, SC, Montgomery, AL, Richmond, VA, Tampa, FL, Virginia Beach, VA, and West Palm Beach, FL. South University also has two instructional learning sites in High Point, NC, and Orlando, FL. Programs and curricula are consistent across the campuses. South University was founded in 1899 in Savannah, Georgia. A feasibility study is included in the Board packet on the Bridge. The proposed BSN program will be housed in the Health Professions Building. South University's Savannah campus celebrated its largest graduating class in the institution's history in June 2021, when more than 3,500 students received degrees. Presently South University Savannah has a total of about 5,405 students, with about 2,000 students attending on campus. In August 2022, an analysis was conducted to review all open Registered Nurse (RN) positions in the Savannah, GA and surrounding area. The search disclosed 5,268 open positions that were advertised between 8/7/21-8/8/22. The nursing shortage in Georgia can be felt everywhere in the state. All signs indicate that the nursing shortage is only going to get worse. Georgia is in dire need of nurses now. A program of study is included in the board packet along with letters from SACSCOC and CCNE. In addition, there is an 8-year plan for hiring faculty, Continuous Quality Assessment Plan, all nursing syllabi for all nursing courses, curriculum plan, curriculum outcomes, purpose, mission, philosophy, CV's for three faculty members including one program director, five year timeline, and revenue/expenditures. Affiliation agreements are included for St. Joseph's Hospital, Chandler Hospital, Memorial Health University Medical, Landmark Hospital, Effingham Care and Rehabilitation Center, Riverview Health and Rehabilitation Center, Coastal Pediatrics, Effingham Health Department, Community Health Midwife Group & Birth Center, The Place at Pooler, and Healthy Savannah. This proposal is very detailed. **South University has addressed all rules and regulations found in Board Rule 410-8-12. Development and Implementation of New Nursing Education Programs.**

**I recommend granting South University Developmental Approval for their proposed BSN program.**

### **Education – 13 – Healthcare Resources Proposed RN and LPN Reentry Program**

#### **Healthcare Resources Reentry Program (EDUCATION 13)**

This is a thorough reentry program, however one thing that I noted missing was the review of the Georgia Nurse Practice Act and Board rules. **According to Board Rule 410-4-.03(2)© Review of the Georgia Nurse Practice Act and Board rules.**

**I recommend acceptance of this reentry program with the addition review of the Georgia Nurse Practice Act and Board Rules. This was completed and turned in to the NEC on September 19, 2022**

The program currently meets the guidelines. However, we will be adding three (3) additional part-time teaching faculty members in Spring semester 2023 to increase program numbers. Once the adjunct teaching faculty begin next semester, the program's part-time faculty will be greater than the full-time faculty. I encouraged Dr. Lanier to continue recruitment and we can discuss the end of October.

Education – 18 – Herzing University – CORRESPONDENCE - Fraudulent Transcripts

**Herzing University (EDUCATION 18)** Recently, Herzing University has become aware that certain other schools purporting to offer nursing programs around the United States have been issuing transcripts and diplomas to their students falsely claiming to be from Herzing University. Fortunately, a student who attended one such school contacted Herzing University when she learned that Herzing credentials had been submitted to a state Board of Nursing in support of her candidacy for licensure and not those of the school she attended. Legal counsel for Herzing was able to interview this student and learned that the institution she attended, the Center for Professional Training and Development in Orlando, Florida, had sent these false credentials to the state Board of Nursing on her behalf. The analysts are reaching out to me to review all Herzing transcripts they receive. I am following up with Dr. Tyler and Dr. Dina Hewett

Education – 19 – NCSBN - CORRESPONDENCE Military Transcripts

### **NCSBN (EDUCATION 19)**

NCSBN shared the Military Transcript 2016 Analysis. We have had a few military transcripts from Air Force, Army, and Navy. The Army and Air Force align with the GBON requirements however, the Navy curriculum does not align with the GBON PN requirements.
