Public Rules Hearing:

Ms. Cellino called the Public Rules Hearing to Order at 9:55 a.m.

There were no oral or written submissions received regarding the proposed rule changes of Rule 609-8-.02 Late Renewal during the minimum thirty (30) days pre-hearing posting of the rule. Following the rule hearing and discussion regarding proposed amendments, the Board voted to adopt the following proposed rule amendments as posted.

[Note: underlined text is proposed to be added; lined-through text is proposed to be deleted.]

Rule 609-8-.02 Late Renewal

(1) Each license will expire and must be renewed by March 31st of odd numbered years. Licenses not renewed by March 31st of odd numbered years this date may be late renewed during the late renewal period of April 1 – April 30th of the corresponding year with payment of a late renewal fee in addition to the renewal fee. by June 30th of that year by the payment of the current renewal fee, plus an additional late renewal fee of 50% of the renewal fee. Late renewal applications must be accompanied by proof that all CE requirements have been met for the biennium.

(2) Any license not renewed by June 30th following the March 31st expiration date shall automatically become classified as "Administratively Revoked" and the licensee must apply for reinstatement. Failure to renew a license by the end of the established late renewal period shall have the same effect as revocation, subject to reinstatement in the discretion of the Board.

(3) Practicing with <u>an expired a lapsed</u> or administratively revoked license <u>shall be is prohibited by law</u>, and <u>any unlicensed practice during this period may result in disciplinary action for unlicensed practice at the time of reinstatement.</u>

AUTHORITY: O.C.G.A. §§ 43-1-4, 43-1-7, 43-1-19, 43-1-25, 43-44-6, 43-44-7 and 43-44-11

<u>Purpose</u>: The purpose of the proposed adoption is housekeeping in nature and reflects recent changes made to the applicable Joint Secretary Rule, specifically Rule 295-2-13 Licenses Expiring March 31 - Odd Years.

Mr. Mattox motioned, Ms. Hunnicutt seconded, and the Board voted to adopt Rule 609-8-.02 Late Renewal as posted. None opposed, motion carried.

In addition, Mr. Mattox motioned, Ms. Hunnicutt seconded and the Board voted that the formulation and adoption of these Board rules does not impose excessive regulatory cost on any licensee and any cost to comply with the proposed rule cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A. §§ 43-1-4, 43-1-7, 43-1-19, 43-1-25, 43-44-6, 43-44-7 and 43-44-11 and that it is not legal or feasible to meet the objectives of O.C.G.A. §§ 43-1-4, 43-1-7, 43-1-7, 43-1-7, 43-1-7, 43-1-7, 43-1-7, 43-1-8, 43-1-7, 43-1-19, 43-1-25, 43-44-6, 43-44-7 and 43-44-11 to adopt or implement differing actions for businesses as listed in O.C.G.A. § 50-13-4(3)(A), (B), (C), and (D). The formulation and adoption of these rules will impact every licensee in the same manner and each licensee is independently licensed in the field of Speech Language Pathology and/or Audiology. None opposed, motion carried.

Mr. Mattox motioned, Ms. Hunnicutt seconded, and the Board voted that the AG's office memo of statutory authority for the rule revisions heard this date to be released to the Governor's office as presented. None opposed, motion carried

Ms. Cellino motioned, Ms. Arnold seconded, and the Board voted to enter into Executive Session in accordance with O.C.G.A. § 43-1-2(k) and § 43-1-19 (h) to receive and review information pertaining to Applications, Executive session minutes, Attorney General's, Cognizant and Enforcement Reports.
