Limited License Reciprocity Agreements:

Pursuant to O.C.G.A. § 43-38-6(i) the Board holds Limited License Recognition Agreements with other states having licensure requirements substantially equal to the requirements in this state. The agreement between Georgia and these other states allows a licensed private investigator in another state to enter Georgia for a period not to exceed 30 days per case, to complete an investigation that originated in the investigator's state of licensure. A Georgia-licensed investigator would also be able to work in the other state for a 30-day period per case on a case that originated in Georgia. Currently, the Board has Limited License Recognition Agreements with California, Florida, North Carolina, Louisiana, Oklahoma, Virginia, Tennessee, and Alabama.

The Board reviewed correspondence from the Oklahoma Private Protective Services Board, inquiring if there were any updates that the Board was seeking for the Limited License Recognition Agreement that was entered into between the two states in 2002.
