Tripp Mitchell moved, Tim Williams seconded, and the Board voted to re-elect Pam Griggs as Board Chair.

Correspondence:

The Board received correspondence from a licensee requesting a rule change to allow licensed security companies to use green or green and white lights as opposed to amber lights to allow people to distinguish security companies from the other professions that currently use amber lights. Tripp Mitchell moved, Joel Peacock seconded, and the Board voted unanimously to deny the request, nothing that the Board is not currently considering making changes to the Board Rule that applies to lights on vehicles used in the private security business, engaged in security patrol, or operated or occupied by uniformed personnel.

Board Rule 509-4-.04(2) currently, in compliance with O.C.G.A. § 40-8-92, allows vehicles used in the private security business to display flashing or revolving amber lights after obtaining authorization from the Board of Public Safety, so long as the licensee obeys the rules and regulations of the Department of Public Safety. The Board indicated that while the Department of Public Safety does not regulate the use of green or white lights, pursuant to O.C.G.A. § 40-8-92(d), it is unlawful for any person, firm, or corporation to operate any motor vehicle or to park any motor vehicle on public property with flashing or revolving green lights, other than any motor vehicle being used by any law enforcement agency, fire department, emergency management agency, or other governmental entity to designate the location of the command post for such agency, department, or entity at the site of an emergency. The Board sees no issue with using white lights, as long as they are used in conjunction with amber lights and used in compliance with any other relevant state or local laws or rules.

Proposed Rule Amendment:

The Board reviewed and discussed the certificate of active supervision from the Governor's office dated September 20, 2022, vetoing the amendment to Rule 509-2-.02, after having received clarification from the Governor's office on the reason for the veto. Tripp Mitchell moved, Tim Williams seconded, and the Board unanimously voted to post the updated proposed rule amendment and schedule the rules hearing for the March 23, 2023 Board meeting.

Event Staffing:

The Board unanimously voted to table discussion on event staffing agencies until the February 23, 2023 Board meeting.

Unlicensed Practice:

The Board discussed a recent influx of complaints related to allegations of individuals who are licensed to work as Armed Security Guard Employees and/or Private Detective Employees for companies licensed by the Board but are under the impression that they are able to work for an unlicensed company under their employee license with a licensed company. Tripp Mitchell moved, Tim Williams seconded, and the Board unanimously voted to send an email out to all licensees reiterating the licensing requirements and responsibilities for both companies and employees, which are stipulated in the Board's laws and rules. The Board also voted to add an affidavit to the employee application for applicants to acknowledge that they understand this information.

Executive Director's Report

The Board reviewed the Executive Director's report which provided statistical data regarding licensing, complaints, and examinations.
