Late Agenda Item - Ratify Revision to 02/10/2023 Meeting Minutes

- LPC Applications/DWE and Supervision – **Board Discussion Only* – From 02/10/2023 Meeting Minutes – vote to ratify:

“In light of the recent statutory changes to O.C.G.A. § 43-10A-11, reducing the post-degree experience under direction and supervision to two (2) years, effective July 1, 2022, the Board discussed the hourly DWE and supervision hourly requirement as stated in their rules and voted to require only 2000 hours of DWE and 70 hours of supervision for licensure as an LPC in Georgia. This is a reduction from the previously required three (3) years of post-degree experience and supervision equating to 3000 DWE

hours/105 supervision hours and will be reflected in a proposed rule change. The Board also discussed the recent statutory change to the educational requirements (i.e., 60 semester hours or 80 quarter hours) and felt the more stringent educational requirements further justified the reduction in DWE/Supervisions hours necessary for licensure.”
