The ASN program also maintains a four-year average above 80%, Ms. Spears-Spivy respectfully requests that their approval status be changed from conditional to full approval. According to Rule 410-8-.02 Nursing Education Program Approval (4)(b) The granting of Full Approval may be for any period of time up to ten (10) years as determined by the board. If Conditional Approval has been imposed for noncompliance with the identified four-year passing percentage on the licensing examination, the Board at its discretion may grant Full Approval for one (1) year. The one (1) year approval is based upon the program having documented evidence of at least two (2) most recent consecutive graduation cohorts of a passing percentage of at least eighty (80) percent of its first-time writers in each calendar year even though the four-year average is not eighty (80) percent. See documentation in the board packet on the Bridge.

I recommend acceptance of this substantive change/notifications and granting Georgia Northwestern Technical College full approval for one year and at that time, if the Board passage scores remain above 80% a ten-year approval can be granted.

EDUCATION – 04 – Georgia Northwestern Technical College – SUB CHANGE – New Administrator Georgia Northwestern Technical College (EDUCATION 04)

Dr. Elizabeth Anderson, President of Georgia Northwestern Technical College (GNTC), notified the Board that Julie Pledger had resigned as Practical Nursing Director. GNTC selected Mrs. Brandi Thompson MSN, RN as the Program Director for the Practical Nursing Program offered at GNTC. She will have direct oversite of the Practical Nursing Program. Brandi Thompson has been a fulltime faculty member of GNTC and the Practical Nursing Program. She along with Kimberly Jones, Assistant Dean of Nursing, will be the direct points of contact for the GNTC Practical Nursing Program. According to Board Rule 410-9-.07(2)(b) In addition to the qualifications set forth in subsection (a) above, the director of a nursing education program shall have at least a baccalaureate degree in nursing and one (1) year of teaching experience in a nursing education program, (included in the required three (3) years of nursing practice). According to Board Rule 410-9-.12(2) (h) Proposed Program Change Notifications are to be submitted to the board within thirty (30) days. See documentation in the board packet on the Bridge.

I recommend acceptance of this substantive change.

EDUCATION – 05 - Savannah Technical College – SUB CHANGE – Resignation of Administration Savannah Technical College (EDUCATION 05)

On May 1, 2023, Ms. Stephanie Derfus, MS, CDA, Academic Dean of the Health Sciences Division, notified the Board that Ms. Tara Stephen, MSN, RN has resigned as the program director of the ASN program at Savannah Technical College. Advertisement for the position has been approved and posted. Ms. Derfus stated that she understands the feasibility study for the ASN program cannot be submitted until an approved director is in place, as such they will not meet the May GBON meeting deadline. According to Board Rule 410-8-.11(2) all programs must submit a report of all substantive changes. See documentation in the board packet on the Bridge. I recommend acceptance of this substantive change.

EDUCATION – 06 – South College – SUB CHANGE – New Hybrid BSN Program

South College (EDUCATION 06)

On April 26, 2023, Dr. Pamela Wright, DNP, MSN, submitted to the Board a Substantive Change for a new

Hybrid BSN Program. The proposed delivery of the new track will allow all didactic course content to be completed through distance education delivery, including exams for which a lockdown browser and recorded student proctoring with faculty oversight and monitoring through HonorLock within the Canvas Learning Management System will be utilized. Courses are developed under the same consistent Blueprinting review policy. Exam integrity and statistical significance are ensured by a data review analysis both pre- and post-exam. Evidenced-based resources are used in exam creation for Next Generation NCLEX (NGN) principles based on ATI and NurseThink platforms. The ATI and NCLEX preparation exams will still be taken on site at the South College campus location. Students will complete all labs, simulations, and skills check-off activities throughout the curriculum at the campus location and attend clinical sites in rotation as currently offered. In addition, students will be encouraged to utilize the college resources available to all students and be required to complete all remediation processes as appropriate. Providing all approvals are received as expected, the Hybrid BSN students may begin the program as early as fall 2023. As you can see there is an email at the end of the proposal of questions, I thought the Board may want answers for. In addition, South College shared that South College has distance education approval from SACSCOC since 1911, and the BSN program was approved as hybrid delivery. They are sending a notification to CCNE of the additional pathway – CCNE does not require prior approval for program changes but will review and let us know if there are additional questions. According to Board Rule 410-8-.11(2) all programs must submit a report of all substantive changes. See documentation in the board packet on the Bridge. I recommend acceptance of this substantive change.

EDUCATION – 07 – Southern Regional Technical College PN – Administrative and Faculty Changes Southern Regional Technical College (EDUCATION 07)

On March 16, 2023, Ms. Athalena Benton, MSN, RN, ASN Program Director at Southern Regional Technical College, Thomasville Campus, sent a letter to notify the Georgia Board of Nursing of administrative changes at Southern Regional Technical College. As of March 6, 2023, the position vacancies for Vice President of Academic Affairs or Dean of Nursing have not been filled. Dr. Ron O'Meara will continue to fulfill the role of VP of AA and Carla Barrow, VP of Institutional Effectiveness, has been named as the Interim Dean of Nursing.

On May 15, 2023, Ms. Athalena Benton, MSN, RN, ASN Program Director at Southern Regional Technical College, Thomasville Campus, sent a letter to notify the Georgia Board of Nursing of additional faculty and administrative updates.

- As of April 3, 2023, the position of Vice President of Academic Affairs was filled by Dr. Vic Burke.
- As of May 15, 2023, Ms. Bobbie Hester, MSN, RN was named the Dean for Nursing. Her promotion will create a vacancy in the ASN program on the Tifton campus.
- Mr. Jared Swift, MSN, MBA, RN had originally submitted his resignation effective May 19, 2023, but has extended his resignation until July 31, 2023.
- These two vacancies in the ASN program have been posted by the college and are awaiting qualified applicants.
- Ms. Meg Long, MSN, RN, ASN faculty member will be assuming the responsibility of the RN/LPN Re-entry program at Southern Regional Technical College. This role was previously filled by Ms. Athalena Benton, MSN, RNC.

According to Board Rule 410-8-.11(2) all programs must submit a report of all substantive changes. See documentation in the board packet on the Bridge.

EDUCATION – 10 – Correspondence – Albany Technical College

Albany Technical College (Education 10)

On May 8, 2023, Dr. Latrona Lanier, PhD, RN, CNE notified the Board that they have four (4) full-time faculty members, three (3) part-time teaching faculty members, one (1) part-time clinical faculty member, and one (1) full-time faculty member who has a tentative start date for July 1, 2023. Albany Technical College (ATC) was approved by the Georgia Board of Nursing (GBON) in November 2020 to implement a traditional/day hour program. Please note the implementation of this cohort began in January 2023, Spring semester 2023. They anticipate this implementation will increase their program numbers by greater than 25%. Additionally, ATC and its community partner, Phoebe Putney, are currently collaborating on a project known as the Living and Learning Center. The goal for this 45million-dollar project is to substantively increase the number of ASN nurses in southwest Georgia. One of the main goals for this state-of-the-art center is to house our ASN program allowing for a further increase in student numbers. They anticipate this project will come to realization in August of 2024. As the number of students has increased, they have increased the number of nursing faculty to remain in compliance with Rule 410-8-.03(7)(11). These programmatic changes will not interfere with their ongoing program assessments. Their assessments will remain ongoing with Expected Levels of Achievement (ELA) being noted. Data obtained through the evaluation plan is utilized for the maintenance, review, and revision of the nursing program.

EDUCATION - 11 - Correspondence - DEA SAMSH

DEA SAMHSA (Education 11)

On May 8, 2023, the DEA SAMHSA issued a press release that stated- Today, ahead of the expiration of the COVID-19 Public Health Emergency (PHE), the Drug Enforcement Administration (DEA) and the Substance Abuse and Mental Health Services Administration (SAMHSA) issued the "Temporary Extension of COVID-19 Telemedicine Flexibilities for Prescription of Controlled Medications" — a temporary rule that extends telemedicine flexibilities adopted during the COVID-19 public health emergency (PHE). The temporary rule will take effect on May 11, 2023, and extends the full set of telemedicine flexibilities adopted during the COVID-19 public health emergency for six months — through November 11, 2023. For any practitioner-patient telemedicine relationships that have been or will be established up to November 11, 2023, the full set of telemedicine flexibilities regarding prescription of controlled medications established during the COVID-19 PHE will be extended for one year — through November 11, 2024.

EDUCATION - 13 - Correspondence - Allegany College of Maryland - Notification to GBON

Allegany College of Maryland – Notification to GBON (Education 13)

On March 22, 2023, Mr. Rick Cooper, MSN, RN notified the Board by email that Allegany College of Maryland will be offering clinical experiences within the state of Georgia for their online LPN-RN program. They are accredited by ACEN and the Maryland Board of Nursing and the Pennsylvania Board of Nursing. We have two campuses, one located in Maryland and a satellite campus in Bedford, PA. They are requesting clinical experiences for the LPN's wishing to complete their education to be able to sit for the NCLEXRN. We understand clinical contracts will have to be completed. Their online program closely mirrors their face-to-face program. Their on-campus program has been in existence since 1971. The last several NCLEX scores have been 93-100% for our

online program. We currently operate in twelve states: Maryland, Pennsylvania, Virginia, West Virginia, Delaware, North Carolina, South Carolina, Florida, New Hampshire, Ohio, Kentucky, and Texas. The students who enter our online program have multiple criteria they must meet to gain entrance. They must have graduated from an approved LPN/LVN program of study, have an active, unencumbered license, and have worked a minimum of 2,000 hours as a Licensed Practical Nurse. They must pass the entrance exam with a minimum score of 700 to enter at the 2nd semester of the program, which is basic Medical Surgical Nursing, if they score 900 or higher, they enter the last year of the program to complete Mental Health Nursing, Maternal Child Nursing, Advanced Medical Surgical Nursing and Nursing in Society. Our program is a member of the NC SARA agreement and has the approval of the Georgia Commission on Higher Education. I'm hoping to gain your approval and add Georgia as the 13th state to offer our LPN-RN Online program. We were recently rated the number 1 LPN-RN program in the nation by Registered Nursing.org. Two years in a row. He would be more than happy to answer any questions or supply you with additional information. We meet all criteria set forth in the Georgia Nurse Practice Act. All full-time online faculty have a minimum of an MSN. We are accredited by the Middle State Commission on Accreditation.

EDUCATION – 14 – Correspondence – Chattahoochee Technical College

Chattahoochee Technical College (Education 14)

On February 9, 2023, Dr, Kimberli Roberts, PhD©, RN, PMC-NE, ASN Program Director and Course Coordinator informed the board that they have five FTE Faculty members and four PT Faculty on staff to teach in the classroom and they will be going to resume admitting 70 students a year to our programs. In the Fall we plan to admit 50-53 traditional students. We currently have 18 Bridge students.

Site Visits

Education – 15 – Kennesaw State University – Site Visit

Kennesaw State University (EDUCATION 15)

On Thursday, March 20, 2023, Dr. Linda Morgan, Nurse Education Consultant for the Georgia Board of Nursing, made a site visit to Kennesaw State University. Met with the Dean Susan MacLeod Dyess, PhD, RN, AHN-BC©, NE-BC and her administrative team All rules and regulations 410-8 were reviewed. Only one item was noted in relationship to faculty having current GA nursing licenses. This was discussed with the Dean as the faculty member resides in GA and has retained her FL Compact License for the last three years. This was shared with the faculty member and subsequently that faculty member obtained a GA RN multistate license. Kennesaw State University has a large, beautiful building that houses only nursing. Ms. Natara Taylor attended the exit conference. The students love the program and are very driven. They plan to increase their yearly enrollment to 1050 students. They have 92 faculty members and openings for seven more. No recommendations at this time as the one item noted during the visit was immediately resolved.

I recommend acceptance of this report.

Education – 16 – Piedmont University – Site Visit

Piedmont University (EDUCATION 16)

On Thursday, April 6, 2023, Dr. Linda Morgan, Nurse Education Consultant, made a site visit to Piedmont University in Demorest, GA. I met with the President, the VPAA, Faculty, Students, Program Director, and the Interim Dean. I was given an extensive tour of the campus. The students were very pleased with their classes, faculty, clinical placements, curriculum, and staff. They shared that Piedmont is like a small family and the professors are only a phone call away. They felt the nursing family was a tight knit community.

Concerns include 1) The Interim Dean (just appointed as the Dean) teaches a full load of courses with no administrative release time and is Dean over two other programs plus nursing 2) Up until Spring 2023 they had always had an Associate Dean to help with the workload 3) Resources — only one mannequin for 153 students and the one mannequin that they have is also shared with health

sciences which has additional 50 students. The Simulation area is the smallest I have ever seen. Concerned about the number of students they are servicing, and the lab experiences offered based on the lack of equipment.

Recommendations include:

- Administrative release time for the Dean of the College of Nursing and Health Sciences
- Appoint an Associate Dean for Nursing
- Resources needed for the nursing department.
 - The International Nursing Association of Clinical and Simulation Learning (INACSL) recommends at least one mannequin for every three students. They have one mannequin for 203 students. This impacts skills lab too.

I recommend acceptance of this report.

Education – 17 – Abraham Baldwin Agricultural College – Site Visit

Abraham Baldwin Agricultural College (EDUCATION 17)

On Monday, April 10, 2023, Dr. Linda Morgan, Nurse Education Consultant, and Dr. Cindy Summerlin, DNP, MSN, RN, made a site visit to Abraham Baldwin Agricultural College in Tifton, GA. We met with the President, the VPAA, Faculty, Students, Program Director, and the Dean. We were given a tour of the campus. Spoke to Dean and Faculty about why the prior recommendations were not addressed. Faculty voiced continued issues with consolidation. The students were concerned about not having enough practice on taking longer tests like the NCLEX. Students who failed the NCLEX stated they were just too tired to take that many questions. Recommendations include:

- 1) Decreasing the Dean's workload. The Dean teaches full time with no release time for administrative duties. In addition, the program director teaches six hours and has six hours release time for administrative duties.
- 2) To reflect NCLEX-RN testing procedures and complaints by students on not being prepared for the number of test questions on the NCLEX, discuss implementation of a plan to have a minimum of 75 questions on all medical-surgical exams.
- 3) Consider combining the nursing fundamentals and physical assessment course. This will help avoid identified clinical safety issues, i.e., students not being able to perform a head-to-toe assessment if they drop the assessment course but remain in the fundamentals course.
- 4) Ensure your program offerings/tracks are clear. It is unclear to students if they are required to attend summer or not. (Reported to reviewers that Bainbridge students must attend summer, but Tifton students are discouraged from attending summer).

I recommend acceptance of this report.

Education – 18 – Georgia Gwinnett College – Site Visit

Georgia Gwinnett College (EDUCATION 18)

On Wednesday, April 12, 2023, Dr. Linda Morgan, Nurse Education Consultant, made a site visit to Georgia Gwinnett College in Lawrenceville, GA. I met with the President, the VPAA, Faculty, Students, Program Director, and the Dean. I was given an extensive tour of the campus. The students were very pleased with their classes, faculty, clinical placements, curriculum, and staff. CCNE was there while I was there. It was enlightening. GGC has a huge simulation lab and skills lab. Senior students help junior students to practice skills. GGC met every rule in 410-8. There are currently no recommendations.

I recommend acceptance of this report.

Education - 19 - Albany State University - Site Visit

Albany State University (EDUCATION 19)

On Friday, April 21, 2023, Dr. Linda Morgan, Nurse Education Consultant, and Mr. Joshua Batson made a site visit to Albany State University, ASN program, in Albany, GA. We met with the President, the VPAA, Dean, Faculty, Students, Program Directors, and Administrative Assistant. While meeting with the President, VPAA, and Dean it was understood that nursing is a vital part of the university. We were given an extensive tour of the campus. The students were pleased with

their classes, faculty, clinical placements, and curriculum. Discussion with the admin team started with discussing the GBON recommendations from 2022 which included hiring an associate chair. The Chair teaches half time along with admin duties. Mr. Batson reiterated the importance of the school of nursing for ASU. At the exit conference, it was reiterated the Board's recommendation at the 2022 site visit of an associate chair. They were agreeable. On 5/17/2023, I received an email from the Dean stating they were moving forward hiring. Secondary to ACEN's most recent report that stated that Albany State University's ASN program was in non-compliance with Standard 6 Outcomes, Criterion 6.2-There is a lack of evidence that the expected level of achievement for first-time test-takers during the same 12-month period on the licensure examination has been met and Follow-up report due Spring 2024, recommendations include:

- Decrease the Chair of Nursing's workload for Summer and Fall 2023
- Hire an Assistant Chair of Nursing to assist the Chair.

I recommend acceptance of this report.

Education – 20 – Southern Regional Technical College – PN - Site Visit

Southern Regional Technical College (EDUCATION 20)

On Monday, May 1, 2023, Dr. Linda Morgan, Nurse Education Consultant, made a site visit to Southern Regional Technical College PN Program in Thomasville, GA. I met with the President, the VPAA, Interim Dean, Program Director of the PN program, one Faculty, Students, Program Director, and the Interim Dean. I was given an extensive tour of the campus. The students were very pleased with their classes, they spoke very highly of the faculty, they stated that they were stressed going to nursing school, they felt clinical placements were adequate, they enjoyed the curriculum, and that staff was very helpful to students. I had one concern after reviewing workload, the PN Program Director teaches full time, four days a week, this does not provide for time for administration. I recommend that they give the PN Program Director at least one day of administrative time. There were no other recommendations, the PN program was prepared for my visit and had provided me with all the resources that I asked for electronically and they were available hard copy when I got there. The program met all the rules and regulations of 410-9. Recommendation-

 Decrease PN Program Director's workload by 25% to provide time for administration of the program and faculty located at multiple school sites including Bainbridge, Moultrie, Tifton, Blakely, and Thomasville.

I recommend acceptance of this report.

Education – 21 – Southern Regional Technical College – ASN - Site Visit

Southern Regional Technical College (EDUCATION 21)

On Tuesday, May 2, 2023, Dr. Linda Morgan, Nurse Education Consultant, made a site visit to Southern Regional Technical College's ASN program in Thomasville, GA. I had met with the President, the VPAA, and the Interim Dean on Monday and as they are all busy people, we decided to discuss both programs at that time. It was apparent that the administrative team was very supportive of nursing. I was given an extensive tour of the campus. Their simulation lab was cutting edge. While talking with the students it was obvious that they were very pleased with their classes, faculty, clinical placements, and curriculum. Athalena Benton, MSN, RN, has a wonderful faculty. I observed the faculty going above and beyond to engage students. The student exemplars were astonishing. I even commented to one male faculty member that he should publish his teaching engagement concepts. There are currently no recommendations as all rules and regulations for 410-8 were met at 100%.

I recommend acceptance of this report.
