Proposed Legislation:

The Board reviewed and discussed any bills or proposed statutory changes which would impact the industry or the Board, including HB 155, SB 157, SB 195, and HB 410.

Class III Exam Review Committee:

At their February 15, 2023 meeting the Board voted to form two committees to review WPI's Wastewater Operator I and II exams and Water Operator I and II exams in an effort to determine which exams would be most appropriate for Georgia applicants to be Class III Operators. The Board currently uses the WPI Wastewater Operator and Water Operator II exams for the Board's Class III certifications.

After reviewing both exams, the Water Treatment Class III Exam Review Committee recommended the Board use the WPI Level I Water Treatment Plant Operator Exam for the Georgia Class III Water Treatment Plant Operator Exam. The committee noted that while they felt both exams that they reviewed were relevant, they believed the Level I exam to be the most appropriate exam for the entry level operators.

After reviewing both exams, the Wastewater Treatment Class III Exam Review Committee recommended the Board use the WPI Level I Wastewater Treatment Plant Operator Exam for the Georgia Class III Wastewater Treatment Plant Operator Exam. The committee noted that while they felt both exams that they reviewed were relevant, they believed the Level I exam to be the most appropriate exam for the entry level operators.

Class IIIG Update:

The Board discussed updates on the development of the new Class III Groundwater Operator subclass and precertification exam. Margaret Doss noted that the Class III Groundwater Committee met on March 28th for a final review of the exam, which was reviewed and approved by the Committee. Kenny Green moved, Debbie Wright seconded, and the Board unanimously voted to set a target date of October 1, 2023, to roll out the new subclass, which is contingent upon EPD's rule approval to recognize the subclass, as well as the deployment of the Secretary of State's Office's new licensing system.

Executive Director's Report:

The Board reviewed the Executive Director's report, which provided the Board with data relevant to the applications received, pass rates for exams, and active licenses for calendar year 2022. Gil Shearouse moved, Debbie Wright seconded, and the Board unanimously voted to accept the Executive Director's Report.
