Board Updates:

- All individuals seeking licensure as Behavior Analysts are required to file a complete **application** for licensure by September 30, 2025. All individuals seeking licensure as Assistant Behavior Analysts are required to file a complete application before March 31, 2026. Appropriate applications not submitted by the above dates, may be considered as practicing without a license pursuant to O.C.G.A. §43-7A-6. ***Board hereby acknowledges that the issuance of a license is not required by the stated deadline; however, a complete application must be submitted and in process by the established dates to be considered in compliance.*
- To avoid delays in processing, Assistant Behavior Analysts (ABA) must first secure appropriate supervision and ensure their supervising Behavior Analyst has applied for licensure before submitting their own application. Assistant Behavior Analysts must be under supervision pursuant to O.C.G.A. 43-7A-5(c)(4); therefore, Behavior Analysts must apply and be licensed before ABA’s can apply and be approved for licensure.
- Pursuant to GBI law and the Board bylaws, the administrative staff is not authorized to approve background check registration requests submitted by individuals who have not applied for licensure. Background registration requests shall be denied if a corresponding application for licensure has not been received, or if the application remains in draft or unpaid status.

AFFIDAVIT SUPPORTING CLOSING OF PUBLIC MEETING
