 - Appropriate applications not submitted by the above dates, may be considered as practicing without a license pursuant to O.C.G.A. §43-7A-6. ***Board hereby acknowledges that the issuance of a license is not required by the stated deadline; however, a complete application must be submitted and in process by the established dates to be considered in compliance.*
- To avoid delays in processing, Assistant Behavior Analysts (ABA) must first secure appropriate supervision and ensure their supervising Behavior Analyst has applied for licensure before submitting their own application. Assistant Behavior Analysts must be under supervision pursuant to O.C.G.A. 43-7A-5(c)(4); therefore, Behavior Analysts must apply and be licensed before ABAs can apply and be approved for licensure.

Mr. Lund motioned, Ms. Osborne seconded, and the Board voted to extend the application submission deadline for Behavior Analysts and Assistant Behavior Analysts as discussed and presented. None opposed, motion carried.
