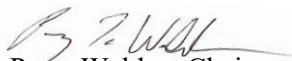
The next meeting of the Georgia Auctioneer Commission will be held Monday, November 24, 2025, at 10:00 a.m.

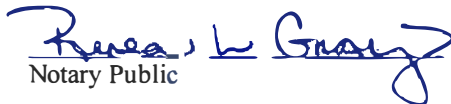
