Ms. Molony called the Public Rules Hearing to Order at 9:15 a.m.

Board received one (1) written submissions received during the minimum of thirty days posting of rules for public input and no oral comments were received during the public rule hearing of the proposed board rules below.

• **75-6-.01 Administratively Processed Applications**

- (1) The Board approves the administrative issuance of licenses by application, reinstatement, or reciprocity between meetings for applicants who:
 - (a) meet all the current requirements for licensure in Georgia.
 - (b) have not been disciplined by any other board.
 - (c) have never been determined by a court or board order to be unable to practice by reason of illness, or received treatment for chemical dependence, drugs, and/or alcohol.
- (2) The Board ~~will~~ shall review any application with an affirmative answer to the conviction question that falls outside of the established Board policy.
- (3) The Board ~~will~~ shall review any application with an affirmative answer to any Board sanction question.
- (4) Administratively issued licenses, including reinstatement, are considered for a vote to ratify at the next regularly scheduled board meeting.

Authority: O.C.G.A. §§43-7A-4 and 43-7A-5

Ms. Osborne motioned, Ms. Locchetta seconded, and the Board voted to adopt Board Rule 75-6-.01 Administratively Processed Applications as posted. None opposed, motion carried.

• **75-6-.02 Cognizant Review**

The Board has elected at least one Board member to work as cognizant on behalf of the Board to review applications and/or complaint/disciplinary matters and shall vote on a replacement for said cognizant member in the event of a

vacancy. All disciplinary/complaint cases reviewed by the cognizant ~~are~~ shall be brought before the Board for a vote of resolution.

Authority: O.C.G.A. §§43-7A-3 and 43-7A-4

Mr. Lund motioned, Ms. Locchetta seconded, and the Board voted to adopt Board Rule 75-6-.02 Cognizant Review as posted. None opposed, motion carried.

• **75-7-.01 Discipline**

(1) Upon finding that a violation has occurred, in accordance with O.C.G.A. § 43-1-19 and 43-7A-7, the Board has the authority to refuse to grant a license to a person, revoke the license of a person licensed by the Board, discipline or sanction a person licensed by the Board, or refuse to renew a license.

(2) In addition, the Board may impose any or all, but not limited to, the following:

- (a) Public or Private Reprimand;
- (b) Letter of Concern;
- (c) Imposition of Fine(s);
- (d) Period of Probation;
- (e) Cease and Desist Order;
- (f) Suspension and/or revocation of the professional license.

(3) Any disciplinary action other than (2) (b) above taken by the Board shall be referred to the certifying entity.

(4) The Board may consider each violation as a separate violation and impose a fine of \$1000 for each offense in accordance with O.C.G.A. § 43-1-20 and 43-7A-6.

(5) The Board shall consider any mitigating circumstances presented by the respondent regarding sanctions, subject to the Board's discretion. Mitigating circumstances shall not include failure to notify the Board of an address change or failure to receive a renewal application or reminder notice.

(6) The Chair gives express consent for the Board's Executive Director or designee, to sign a consent agreement, Voluntary Surrenders, or other Board orders signed by the applicant or licensee under terms voted upon by the Board. The Executive Director ~~will~~ shall present to the full Board at the next scheduled meeting those individuals licensed in this manner for ratification.

Authority: O.C.G.A. §§43-1-19, 43-1-20; 43-7A-4, 43-7A-5; 43-7A-6, and 43-7A-7

Mr. Lund motioned, Ms. Locchetta seconded, and the Board voted to adopt Board Rule 75-7-.01 Discipline as posted. None opposed, motion carried.

• **75-7-.02 Unlicensed Practice**

(1) Individuals who have engaged in the practice of Applied Behavior Analysis without a current, unencumbered, active Georgia license shall be subject to a Voluntary Cease and Desist Order, public reprimand, fine, and/or other sanction imposed by the board, as authorized by law (43-7A-6).

- (a) Mitigating circumstances may be taken into account in varying the amount of assessed fines, subject to the board's discretion.
- (b) Licensees who fail to renew their licenses by the license expiration date, and who continue to practice Applied Behavior Analysis after the license expiration date, have engaged in unlicensed practice and are subject to disciplinary action and fines determined by the board.

(2) It is the responsibility of the licensee to inform the board in writing of a change in any of the following information within thirty (30) days of such change:

- (a) physical address;
- (b) mailing address;
- (c) email address;

- (d) telephone number(s); and
- (e) change of name (must provide legal documentation reflecting name change).

(3) It is the responsibility of each licensee to renew his or her license prior to the license expiration date regardless of whether the licensee receives a renewal notice from the board.

Authority: O.C.G.A. §§ 43-7A-4, 43-7A-6 and 43-7A-7

Mr. Lund motioned, Ms. Osborne seconded, and the Board voted to adopt Board Rule 75-7-.02 Unlicensed Practice as posted. None opposed, motion carried.

- **Rule 75-7-.03 Release of Investigative Files**

(1) Pursuant to the provisions of OCGA § 43-7A, it is the policy of the Georgia Board of Behavior Analysts to authorize the Board staff to release and/or request investigative information to and/or from the following law enforcement agency and/or lawful licensing authority:

- (a) All Georgia County and/or Judicial Circuit District Attorney Offices
- (b) All Georgia County and/or Judicial Circuit District Solicitor General Offices
- (c) All Georgia County, Judicial Circuit, and/or City Police/Investigations Departments.
- (d) Georgia Bureau of Investigation (GBI)
- (e) Federal Bureau of Investigation (FBI)
- (f) United States Department of Homeland Security (DHS)
- (g) United States Immigration and Customs Enforcement (Investigative arm of DHS)
- (h) United States Drug Enforcement Administration (DEA)
- (i) State Licensing Boards

(2) ~~Provided that the written request~~ that any written request for investigative information is requested for the purpose of:

- (a) Conducting a Board investigation which may lead to disciplinary action; or
- (b) An investigation by a law enforcement agency or lawful licensing authority for offenses that may constitute a violation of the laws, rules, and policies of the Georgia Board of Behavior Analysts.

(3) The Board staff shall notify the Board of such request and/or release in writing and such written notification shall become part of the Board's record of investigation. Any release of information shall include statements regarding the statutory confidentiality of investigations by the Board under the provisions of Title 43 of the Official Code of Georgia Annotated.

(4) A list of investigative files released under the terms of this policy will be presented to the Board to be ratified during the Board's next regularly scheduled meeting and will be reflected in the Board minutes.

Authority: O.C.G.A. §§ 43-7A-4, and 43-1-19

Ms. Locchetta motioned, Mr. Lund seconded, and the Board voted to adopt Board Rule 75-7-.03 Release of Investigative Files as posted. None opposed, motion carried.

- **75-8-.02 Advertising**

(1) It shall be considered a violation of the Applied Behavior Analysis Practice Act to:

- (a) publicly misrepresent oneself to be a licensed Behavior Analyst or licensed Assistant Behavior Analyst in any form of advertisement unless the individual has an active, valid license issued by the Board to practice Applied Behavior Analysis in Georgia (43-7A-6).

(2) Only duly licensed Behavior Analysts or Assistant Behavior Analysts practicing in accordance with the Board rules and Georgia law may practice Applied Behavior Analysis in Georgia or use in connection with their own name or that of their business or employer, the terms Behavior Analyst, Assistant Behavior Analyst, or the letters LBA or LaBA. or any other representation either direct or indirect, indicating to the general public that Applied Behavior Analysis is provided or available. Such activities are prohibited unless the provider is an actively licensed Behavior Analyst (LBA) or Licensed

Assistant Behavior Analyst (LaBA) by the Georgia Board of Behavior Analysts.

Authority: O.C.G.A. §§ 43-7A-2, 43-7A-4 and 43-7A-6

Mr. Lund motioned, Ms. Osborne seconded, and the Board voted to adopt Board Rule 75-8-.02 Advertising as posted. None opposed, motion carried.

Ms. Osborne motioned, Ms. Locchetta seconded, and the Board voted that the memo of statutory authority for all the rule revisions heard this date to be released to the Governor's office as presented. None opposed, motion carried.

In addition, Ms. Locchetta motioned, Ms. Osborne seconded and the Board voted that the formulation and adoption of all above rules does not impose excessive regulatory cost on any licensee and any cost to comply with the proposed rule cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A. §§ §§ 43-1-19, 43-1-20, 43-7A-2,43-7A-3, 43-7A-4, 43-7A-5, 43-7A-6, and 43-7A-7 and that it is not legal or feasible to meet the objectives of O.C.G.A. §§ §§ 43-1-19, 43-1-20, 43-7A-2,43-7A-3, 43-7A-4, 43-7A-5, 43-7A-6, and 43-7A-7 to adopt or implement differing actions for businesses as listed in O.C.G.A. § 50-13-4(a)(3)(A), (B), (C), and (D). The formulation and adoption of these rules will impact every licensee in the same manner and each licensee is independently licensed in the field of Applied Behavior Analysis.

Ms. Osborne motioned, Mr. Lund seconded, and the Board voted to enter Executive Session in accordance with O.C.G.A. § 43-1-2(k) (1) (2), O.C.G.A. § 50-14-2(1), O.C.G.A. § 43-1-2-(k) (4), O.C.G.A. § 43-1-19 (h) (2) & (4) to discuss and review memos from the Assistant Attorney General's Office, discuss and review applications, and review previous executive session meeting minutes. Voting in favor of the motion were Board members present Molony, Osborne, Locchetta, Lund.

At the conclusion of Executive Session on Thursday, December 18, 2025, Ms. Molony declared the meeting into "open" session pursuant to the Open and Public Meeting Act O.C.G.A. § 50-14-1 et seq. No votes were taken in Executive Session.
