(Fee includes a \$10 mail in application processing fee).
A licensee may not use his or her license in the State of Georgia while that license is on Inactive Status. Board Rule Chapter 510-7-.03 (a) RETURN YOUR CURRENT "ACTIVE" POCKET CARD WITH THIS APPLICATION.
Checks returned for insufficient funds will be assessed a \$40.00 service charge pursuant to O.C.G.A. §16-9-20.
