

CREDENTIAL EVALUATION SERVICE AGENCIES

Applicants educated in foreign countries that wish to obtain a license as a Long-Term Care Facility Administrator must have their credentials evaluated by an independent foreign credential evaluation service.

The applicant must request a course-by-course evaluation in American semester hours with specific notation as to those courses completed at the graduate level. The applicant must also request that the agency indicate the equivalent highest level of education the applicant has completed.

The applicant will need to complete the application for licensure and submit the application, along with an official copy of the translation received from the foreign credential evaluating agency.

The Board does not recommend or endorse any of the agencies. This list may not be exhaustive and other agencies may be considered if they are able to provide the information required.
