- **135-9-0.3-.01 Emergency Rule: COVID-19 - In Person Continuing Education Requirements for Renewal 09/30/2020**
Effective Date: April 2, 2020
Due to the COVID-19 State of Emergency, for the 2018-2020 renewal cycle only, there shall be no limit on the number of continuing education hours, including ethics hours, that may be obtained online, by any method. This rule shall be effective for the duration of the emergency and for a period of not more than 120 days thereafter. *Amended 06/24/2020 - Includes CE Hours required for reinstatement/reactivation applicants
